

3. The appointment is subject to fulfillment of the following conditions:
 - 3.1 The appointment is purely on contract basis for a period of 06(six) months only from the date of joining in the post or may be extended as per Covid-19 situation.
 - 3.2 This will not confer any right to the candidate for regular appointment under the State Government.
 - 3.3 The appointee carries liability to serve anywhere in the State in public interest.
 - 3.4 The furnishing the false information or suppression of any factual information would be a disqualification and is likely to render the candidate unfit for employment and liable for legal action.
 - 3.5 No TA/ DA will be allowed for joining the post.

3.6 The appointment will be further subject to :

- a. Production of certificate of fitness from Govt. Medical Officer, Tripura / Govt. Female Medical Officer (for female candidates).
- b. Production of following Certificates :
 - I. Registration certificate (attested copy);
 - II. Educational qualification certificate (attested copy);
 - III. Certificate of Age (attested copy);
 - IV. Certificate in the prescribed form in support of the candidate's if belonging to Schedule Caste/ Tribe;
 - V. Discharge certificate of previous employment, if any (attested copy) ;
 - VI. Permanent Resident Certificate of Tripura / address proof certificate.
4. His /Her pay shall be debitable under Head of Account 2210-06-001-98-52-28 Demand-52 (Professional Service).
5. The appointee is directed to report for duty to his/her place of posting within 05(five) days from the date of issue of the Memorandum, falling which the appointment order shall be treated as cancelled.
6. 06(six) days casual leave is admissible during the period of engagement. No other leave is admissible.
7. The appointee should first report to the officer mentioned in col. No 4 of para-1 by submitting joining report addressed to the Director of Family Welfare & P.M., Government of Tripura, along with all enclosures and Attestation Form (duly filled in).
8. The eligible candidates job responsibilities for specifically field activities will be assigned by the Chief Medical Officer to combat Covid-19 situation.


