Important Instructions to the candidates for engagement of contractual posts under Tripura State AIDS Control Society :

1. Interested candidates will have to submit application in the prescribed format (Annexure-I) & relevant self attested documents by hand/by registered post in a sealed envelope with super scribed name of the post as "Application for the post of....." & "Applicant's name..... S/o D/o W/o" addressed to the O/o The Project Director, Tripura State AIDS Control Society, Akhaura Road, opposite to IGM Hospital, Agartala, Tripura West-799001 by 24th December,2021. Authority will not be liable for any postal delay.
2. The engagement (contractual) will be for 11(Eleven) months / up to the project period initially, which may be extended based on the performance of employees/ continuation of the same project.
3. **Age limit:** 18 to 40 years. Upper age limit relaxable by 5 years for SC/ST/Ex-Service Men Candidates. The age should be computed based on the last date of submission of application i.e., on 24th December,21. The age limit for the post of Medical Officer is 65 years.
4. Reservation as per State Govt. norms.
5. After recruitment, the staff shall be put on probation for 3 (Three) months, prior to end of probation period performance evaluation shall have to done in order to assess whether the contract should be terminated for non performance or whether the probation should be extended
6. The total examination will be conducted of 100 marks (90 written examination & 10 viva).
7. To eligible in the interview, a candidate has to obtain minimum 60% marks or more in the written examination.
8. In the written examination, there will be multiple choice questions (MCQ) on the subject related. Each question will carry 2 marks (45 questions) and there will be negative marking of 1 mark for every wrong answer. Questions will be based on subject syllabus, current affairs and HIV/AIDS matter.
9. Any correction made in the choice of answers by a candidate against an MCQ will have to be authenticated by his dated initial against the discarded answers and failure to do so shall be deemed as the question remaining unanswered, with no award or deduction of any mark.
10. Merit list of the candidates will be prepared as per the marks obtained and in case more than one candidate secures the same mark, then merit list will be prepared as per age seniority. In case, more than one candidate is in the same age then alphabetically seniority list will be prepared in the instant case.
11. Name of the eligible short listed candidates for appearing in the written preliminary Competency Assessment Test will be published in the Office Notice Board of Tripura State AIDS Control Society and uploaded in (<http://health.tripura.gov.in>) & (<http://tsacs.tripura.gov.in>)



12. The date, time, venue & other details of the written preliminary Competency Assessment Test will be published in (<http://health.tripura.gov.in>) & (<http://tsacs.tripura.gov.in>) and Society Office Notice Board after reviewing the submitted application status.
13. Successful candidate of preliminary Competency Assessment Test will be called for personal interview in the ratio of 1:3. The date, time, venue & other details of the interview will be published in <http://health.tripura.gov.in> & (<http://tsacs.tripura.gov.in>) and Society Office Notice Board. The marks obtained by the candidate on the Preliminary Competency Assessment Test will carry forwarded in the interview.
14. No communication will be made through issuing call letter or publishing in the local news dailies further during the next procedure of written Competency Assessment Test and the interview, except in website and Society Office Notice Board.
15. Final selection will be done by the Recruitment Board for the post applied for, based on Merit List and maintaining 100 point roster, which will also be published in the website and Society Office Notice Board in due time.
16. The number of post(s) may be increase/decrease or whole process may be cancelled at any time before or after interview.
