Sir,

With reference to the letter No.F.2(6-339)-MS/SECTT/LAW/2017/2003-111, dated 9th March 2017, we the Members of the Committee formed by the DHS, Govt. of Tripura have gone through all the Hospital records, USG report, Statements of doctors and on duty nursing staffs in connection with the complaints of Shri Mridul Kr. Deb and Smt. Tanushree Datta (Deb) on 01.02.2017.

During enquiry the following facts were revealed:

1. Smt. Tanushree Datta (Deb), aged 30 yrs attended the OPD of Obstetrics & Gynaecology Department, AGMC & GBP Hospital, Agartala, Unit-III on 13.05.2015 with diagnosis of Primigravida at 38 weeks pregnancy with gestational diabetes mellitus and severe pregnancy induced hypertension with Intra Uterine Foetal Death (IUFD). On examination Fetal Heart Sound (FHS) could not be detected. The USG report done on 12.05.2015 showed that it was a case of gross Intra Uterine Growth Restriction with Intra Uterine Foetal Death (IUFD) and **it was conveyed to Smt. Datta during USG procedure by sonologist Dr. R. K. Chakraborty.** Being diagnosed to be a case of Intra Uterine Fetal Death clinically and ultra sonographically the patient Smt. Tanushree Datta (Deb) was advised for admission in Gynaecology IPD on that day. **During admission the mother of the patient was informed about the condition of her baby that baby was not living (IUFD).**
2. After admission she was managed properly and under observation. Necessary investigations were done as required. Labour was induced medically. At 1.55 a.m. on 17.05.2015 she delivered vaginally a macerated still born male baby weighing 1.5 kg without any complication. Examination of the baby revealed cord round the neck and fetal ascites and it was **macerated still born (as per delivery note in Bed Head Ticket).** As per existing protocol of the department all the babies whether live or still born is shown to the patient and the attending family members. So, in this case the baby was shown to the mother and attending family members by the on duty doctor & nursing staffs. As per existing rule in the State of Tripura, no Death Certificate issued for still born baby. Still born babies are disposed by the hospital authority only when patient party refuse to take the baby. In this case also the baby was officially disposed by the hospital authority as the patient party refused to take the baby. Official copy of the disposal of the baby from the ward master office proved that.

3. From the enquiry of Bed Head Ticket with documents, it was found that another lady namely Smt. Sitan Deb, W/O Nirmal Deb of Ambassa was referred from the Modern Psychiatry Hospital, Narasingarh with labour pain on 15.05.2015 at 11.10 p.m. for delivery. She was a patient of Schizophrenia and under the treatment of Modern Psychiatry Hospital of Narasingarh. Smt. Sitan Deb was admitted at AGMC & GBP Hospital in the Department of Obstetrics and Gynaecology at 12.10 a.m. on 16.05.2015. She delivered a live Male baby weighing 2.1 kg on 16.05.2015 at 2.25 a.m. Mother and baby were transferred to the Post Partum Ward. As the mother was a schizophrenic patient the baby was shifted to the Deepjyoti Specialized Adoption Agency, Abhoynagar, Agartala and the baby was received by the Superintendent, Deepjyoti Specialized Adoption Agency as per order No.F.3(24-2)/cwc/Restoration/1012(IV) dated 16.05.2015 of the Chairperson, Child Welfare Committee, West Tripura. **So, this baby was shifted prior to the birth of the baby of Tanushree Datta (Deb).** So question of exchange of babies does not stand for.
4. From the above facts, we the members of the committee unanimously come to the conclusion that :
- A) Smt. Tannushree Datta (Deb) a diagnosed case of Primi with IUFD admitted on 13.05.2015 in Gynae IPD of AGMC & GBP Hospital from OPD under Unit-III. At the time of admission her mother was informed about the condition of her baby that baby was dead. Smt. Tanushree Datta (Deb) also was informed about IUFD during USG procedure on 12.05.2015.
- B) She delivered a macerated still born male baby on 17. 05.2015 at 1.55 a.m. without any complication. The baby was macerated as would be in a case of IUFD for more than 5 days.
- C) Smt. Sitan Deb, a patient of Schizophrenia delivered a live male baby on 16.05.2015 at 2.25 a.m. which was shifted to Deepjyoti Specialized Adoption Agency as per order of Chairperson, Child Welfare Committee, Tripura on 16.05.2015, that is prior to delivery of Tanushree Datta.
- D) So, the allegation made by Smt. Tanushree Datta (Deb) & Mridul Kr. Deb against the three Doctors namely Dr. Rajat Kumar Chakraborty, Sonologist, Dr. Salilbindu Chakraborty, Obstetrician & Gynaecologist and Dr. Amulya Debbarma, Obstetrician & Gynaecologist are false and does not stand for.

With reference to the subject mentioned above, I am to inform you that an enquiry committee headed by Dr. Mamata Pradhan, Professor & HOD, Department of Obst & Gynaec, AGMC, Agartala as Chairman was constituted by the authority to enquire into the matter i.e. on the complaint of Sri Mridul Kumar Deb & Smt. Tanushree Datta (Deb). The said committee has enquired into the matter in detail and submitted its report on 29-03-2017, wherein, it is clearly opined that Smt. Tanushree Datta (Deb), a diagnosed case of Primi with IUFD was admitted on 13-05-2015 in Gynae IPD of AGMC & GBP Hospital from OPD under Unit-III. At the time of admission, her mother was informed that baby was not alive. Smt. Tanushree Datta (Deb) also was informed about this IUFD during USG procedure on 12-05-2015. On 17-05-2015 at 1.55 a.m. Smt. Datta (Deb) delivered a macerated still born male baby without any complication, and the baby was macerated, as would be, in a case of IUFD for more than 5 days. It is also concluded that one Smt. Sitan Deb, a patient of Schizophrenia, delivered a live male baby on 16-05-2015 at 2.25 a.m. which was shifted to Deepjyoti Specialized Adoption Agency as per order of Chairperson, Child Welfare Committee, Tripura on 16-05-2015, that is prior to delivery of Tanushree Datta (Deb). Finally, the Enquiry committee opined that the allegation made by Smt. Tanushree Datta (Deb) & Sri Mridul Kumar Deb against the three Doctors namely Dr. Rajat Kumar Chakraborty, Sonologist, Dr. Salilbindu Chakraborty, Obstetrician & Gynaecologist and Dr. Amulya Debbarma, Obstetrician & Gynaecologist are not true.

This is for your kind information and taking further necessary action from your end.
