The institute (NIHFW), an autonomous Institution under the Ministry of Health and Family Welfare, Government of India is conducting various Diploma Courses through Distance Learning mode for more than two decades. These courses will help to enhance the work efficiency of an employee. Duration of each course is 01(one) year. - Develop the ability to translate research into practice through skills in nutrition surveillance, policy/ programme planning, implementation and evaluation as well as overall management of the programmes
- Conceptualize the interdisciplinary perspective of PHN at all levels – individual, household and community in the context of state, national and international scenario

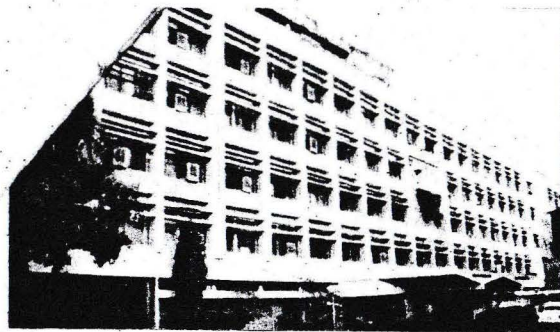

The post-graduate education and training, research and evaluation, consultancy and advisory services, specialized projects and services in the field of health and family welfare have been the major focus of the Institute. Objectives of the Course

- Apply the managerial skills to develop the health system

Eligibility

- **MBBS/ BDS/ Bachelor of AYUSH-** must be registered with respective State Medical or Indian Medical Council, Doctor qualifying MBBS from abroad must have cleared the MCI test.

- **B.Sc.(Nursing)/ M. Pharma-** Registered with respective State Council. Minimum two Years experience in a Govt./NGO/ Private or Corporate Institution as on 31st May, 2017.
- **Physiotherapist/Occupational Therapist/B. Pharma-** Registered with respective State Council. Minimum 5 years experience in any recognized Institute as on 31st May, 2017.

2. Diploma in Hospital Management:

Objectives of the Course

On successful completion of the course, the candidate will be able to:

- Describe clearly the basic concepts of management and hospital management
- Apply the managerial skills in hospital environment
- Describe how to manage finance, human and material resources in hospital
- Describe planning and management of hospital and health care services
- Describe planning of patient care and hospital support services
- Formulate a research project

Eligibility

- **MBBS /MS / MD / MCH, Dental Surgeons and AYUSH Doctors-** must be registered with respective State Medical or Indian Medical Council. Doctor qualifying MBBS from abroad must have cleared the MCI test.
- **B.Sc. Nursing / M. Pharma-** Registered with respective State Council. Minimum two years experience in a Govt./NGO/Private or Corporate Institution as on 31st May, 2017
- **B. Pharma / Bachelor in Physiotherapy/Occupational therapy / Dieticians-** must be registered with respective State/National Council. Five years experience in a Govt./NGO/Private or Corporate Institution as on 31st May, 2017.

3. Diploma in Health Promotion:

Objectives of the Course

On successful completion of the course, the candidate will be able to:

- Describe the concept of health and health promotion
- Describe the basics of health and disease in a holistic manner
- Enumerate the role of social determinants of health and other sectors
- Mainstream health promotion in the National Health Programmes (NHPs) and National Health Mission (NHM)
- Evaluate the policy context of health promotion and the effective use of resources in different settings
- Design strategies for health promotion in different settings

- Analyze and interpret available data at district, state and national level for health promotion
- Describe the concept of health education, information, education and communication, behaviour change communication for health promotion
- Plan, monitor and evaluate the health promotion programmes

Eligibility

- **Master's in Science, Behavioral Science, Management, Commerce-** Successful completion/ registration with State Council, one year experience, in any Govt. / AICTE recognized Institute as on 31st May 2017.
- **All Medical Graduates and /BDS/Bachelor of AYUSH-** Must be registered with respective state/National Council, Candidates having degrees from abroad must have cleared MCI test.
- **Bachelor in Science, Behavioral Science, Management, Commerce-** Successful completion, two years experience in any Govt./ AICTE recognized Institute as on 31st May, 2017.

4. Diploma in Health Communication:

Objectives of the Course

On successful completion of the course, the candidate will be able to:

- Describe communication theory and practice
- Describe the basic concepts of health and diseases in various cultural contexts
- Utilize communication channels to inform the target audience on health
- Explain the media law and advocacy programs
- Design a health communication strategy
- Monitor and evaluate the health communication programs

- **All Medical Graduates (MBBS/ Dental/ AYUSH)-** Must be registered with concerned State council or Indian Medical Council.
- **All graduates of Media/ communication/ Publicity/ News Reporter-** one year experience after successful completion of the course as on 31st May, 2017.
- **Any graduate of recognized courses of TV, Radio, Broadcasters -** two years experience of working in the field communication or Media Reporting as on 31st May, 2017.

5. Diploma in Applied Epidemiology:

Objectives of the Course

On successful completion of the course, the candidate will be able to:

- Acquire knowledge of various epidemiological techniques and uses of Epidemiology
