
With reference to your tender submitted dated 27/12/2016, you are hereby appointed as a carrying contractor for carrying of different items of stores of Health & Family Welfare Department at the rate of **Rs 1.14(Rupees one and paisa fourteen) only per Kilometre per 100kg.** including ,fuel charge, loading ,unloading ,ferry charge and incidental charges(if any) as per terms & conditions of the agreement bond executed between you and Director of Health Services, on behalf of the Government of Tripura in reference of tender notice issued under this Directorate letter dated 06/12/2016. This appointment should take effect from 28/2/2017 and **(valid up to 31-03-2018).**

Bill for freight charges paid by you and carrying charge should be submitted separately in triplicate to the concerned officer after completion of work duly supported by necessary receipt and vouchers.


VAT shall be deducted from carrying bills under the provision of Tripura Value Added Tax Rules.
