M E M O R A N D U M

With reference to this office memorandum No.F.10(10)-SBHI/2006 dated, 4th May 2010 to introduce the system of ICD-10 coding for Indoor patients in all the Medical health institutions of the State from 01-07-2010 and also to put the ICD -10 code in the bed head ticket of the patients against the provisional /final diagnosis at the time of admission of the patients in the medical institution, it is observed that , most of the health institutions are not properly maintaining the system to put the ICD -10 code in the bed head ticket of the patients against the provisional /final diagnosis.

All the CMO's are hereby requested to issue letter to all the Sub-Divisional Medical Officer , Medical Officer In-Charges of CHC & PHC under their jurisdiction to instruct to put the ICD -10 -code in the bed head ticket of the patients against the provisional /final diagnosis at the time of admission of the patient in the medical institutions .

The Medical Superintendents of all the State Hospital , District Hospital are also requested to instruct all the Medical Officers & Nursing Staffs under their jurisdiction to put the ICD -10 -code in the bed head ticket of the patients against the provisional /final diagnosis at the time of admission of the patient in the medical institutions .

Similarly Medical Officer In-Charges of State Homeopath & State Ayurvedic Hospital are also requested to instruct all the Medical Officers & Nursing Staffs under their jurisdiction to put the ICD -10 -code in the bed head ticket of the patients against the provisional /final diagnosis at the time of admission of the patient in the medical institutions .
