NOTICE INVITING TENDER

Tenders in sealed covers are hereby invited for the year 2014-2015 by the Director of Health Services, Government of Tripura, Agartala (on behalf of the Governor of Tripura) from the resourceful, experienced, reliable, bonafied, renowned, licensed **Manufacturer of Medicines** for supply of Medicines who are supplying Medicines to the following institution(s).

- i)(AIIMS, New Delhi.
- ii) Safdarjung Hospital, New Delhi.
- iii) P.G.I., Chandigarh
- iv)S.S.K.M., Kolkata
- v)National Institute of Mental Health & Neuro Science, Bangalore.
- vi)Christian Medical College(CMC),Vellore.
- vii)TATA Memorial Cancer Hospital ,Mumbai.

Distributors/ Suppliers /Agents /loan Licenses are not eligible to participate in the tender.

The list of Medicines with specification and approximate yearly requirement is enclosed with the Tender form.

The tender will remain valid upto 31/08/2016. The Director of Health Services, Govt. of Tripura reserves the right to extend the rate for 2nd year to the approved supplier and on the basis of satisfactory performance and execution of supply orders in time and in terms of quality.

TERMS & CONDITIONS

1. Tenders will be received by Speed Post / Registered Post/Courier Services only in sealed covers addressed to “ Director of Health Services, Government of Tripura, Gorkha Basti Office Complex, P.O. Kunjabon, Agartala-799006” up to **4 P.M of 19/06/2015**. Tenders received after the aforesaid date and hours shall not be considered. The Director of Health Services shall not remain responsible for any postal delay. Tenderers are requested to provide detailed address along-with Pin Code, phone and Fax numbers and S.T.D. code number for easier communication.
2. On the top left side of the sealed tender enquiry number and date, due date of opening and name & address of Tenderers should be mentioned. Tenders are likely to be opened on **24/06/2015 at 11.30 AM**, if possible. Tenderers or their representative may remain present at the time of opening of the tenders.
3. The interested bidders shall submit the bids in 2 parts, namely “Financial Bid” and “Technical Bid”. The 2-bids should be put in two separate sealed envelopes, indicating on the cover as to which one is the technical bid and which one is the financial bid. The 2 envelopes shall, thereafter, be placed inside a large sealed cover and the same may be submitted. The “Technical Bid “ shall contain all details regarding the list of Medicines offered by the bidder, compliance of terms and conditions, submission of documents etc. in other words, everything except the rate offered. The “Financial Bid” shall contain only the rate offered by the bidder. While processing the bids, the technical bids will be opened first and the eligible bidders meeting requirement will be short-listed. Thereafter, financial bids of only short listed bidders will be opened for consideration”.

4. List of Medicine(s) with detailed specification and name of manufacturer ,quoted by the bidder, is to be enclosed in the Technical bid.
5. Tender should not be submitted for the product/products for which the concern/company has been blacklisted/banned/debarred either by Tender inviting authority of Govt.of Tripura or by any other State/Central Govt.and its Drugs procurement agencies.
6. The concern/company/firm which stands blacklisted/banned /debarred either by Tender inviting authority or Govt.of Tripura or by any other State/ Central Govt.and its drug procurement agencies on the date of bid submission shall not be eligible to participate in the tender.
7. The concern/firm/company whose product has been declared as of spurious or adulterated quality and any criminal case is filled and pending in any court shall not be eligible to participate for that particular products, in the tender. Similarly convicted firm/company shall also not be eligible to participate in the tender.
8. Non conviction certificate issued by the Drugs Controller of the state must be produced. It should be recent and not more than one year old.
9. The manufacturers having Marketing Agency at Agartala , Tripura will be preferred during consideration of rate & firm by a constituted committee. Marketing agency should have Valid Drug licence issued under the Drugs & Cosmetic Rules,1945.
10. The supply of Medicines must be executed within 3(three) months from the date of manufacture for the drugs which are having shelf life (Expiry date) of 1(One) year and for those drugs having more than 1(One) year shelf life the supply must be executed within 6 (Six) months from the date of manufactur, but the time period between date of supply & date of expiry shall not be less than 1(one) year .
11. Medicines must be supplied directly by the manufacturers itself or by its authorized distributors and should obtain sales tax clearance before delivery. An authorized representative of the firm should remain present during delivery of the ordered quantity. Authorized representative shall have to furnish appropriate credential from the firm they represent.
12. **The Manufacturers must have to submit Performance Report in respect of timely execution & quality of Medicines at least for preceding two years from the concerned institutions (mentioned in the tender notice) to whom they are supplying.**
13. The supply order of Medicines must be completed within 90 (ninety) days from the date of issue of order. A penalty @ 1% on the total value shall be charged for every week or part of week of delay beyond stipulated date of supply. However, Relaxation will be entertained only in special circumstances (Natural Calamities, War or any other situation beyond human control). Order must be executed by supplying the items batch wise and maximum quantity of each batch is to be supplied.
14. **During execution of supply orders , the manufacturers will have to submit the Test Report / Certificate of Analysis of Medicines / Drugs from the manufacturer itself and in addition they will have to submit the Test Report / Certificate of Analysis of Medicines / Drugs from NABL accredited Laboratory.**
15. State Drug Control Administration may collect of sample of Medicines / Drugs from the Medical Store at random within 3(three) days from date of receipt of drugs at store.

16. If any batch of drugs supplied is found to be not of standard quality after testing, the total quantity of sub standard batch supplied should be taken back and replaced by fresh stock at own cost of supplier irrespective of whether any part consumed or not.

17 Failure to supply Standard quality of drugs by the Tenderers or his authorized distributor will render him disqualified along-with the manufacturer of the drugs for future supply / Tender.

18 If ordered quantity is less and ordered value is less than Rs. 50,000/- only for one item of medicine, the medicine will be receipt with test report of manufacturer itself and the medicine will be tested at SDTL, Agartala for which testing facilities is available as SDTL. If testing facility is not available at SDTL, then medicines, having less ordered quantity and less than Rs. 50000/- only ordered value will be receipt with test report of manufacture itself.

19 5% of the value of ordered quantity will have to deposited as Security Money by demand draft from any Nationalized Bank by the firm within 10 days time from the date of issue of supply order. The Security Money will be released after completion of full supply within stipulated period or it may be kept for the next supply order whichever is applicable.

20. Income Tax / Other Tax shall be deducted from the bill as per guidelines of the Government, if applicable.

21. Any enhancement of rate within the validity period of contract will not be considered except for imposition of any levy or increase in existing levy by the Government. Any undue request may lead to cancellation of the Order.

22. Payment to successful Tenderers shall be made on bill basis only after completion of supply of the items ordered for. No advance payment shall be made under any circumstances.

23. Extension of rate for supply may be considered for 2nd year to the approved supplier on the basis of satisfactory performance and execution of supply orders in time and in terms of quality.

24. The rate should be typed and quoted both in figure and word clearly in Indian currency. **The unit cost of medicines, rate of CST and rate of VAT should be mentioned separately and clearly at financial bid.**

25. Tenderer should mention the quantity supplied in each packet as per specification. The packet size should never contain more than 1000 pieces **.Items of Tablets and Capsules are to be supplied in strip / Blister packets.**

26. Yearly approximate requirement is incorporated in the list of Medicine which are likely to increase or decrease as per actual requirement. The yearly supply order may be issued once for staggered supply as per requirement.

27. The Medicines should confirm to the Standards mentioned against each item and as laid down under the Drugs & Cosmetic Act & Rules.

28. In case of supply of each and every item the label of packing, strips / blister etc.

should bear the inscription "Tripura Govt. Supply, Not for Sale" in indelible ink. Relaxation, if needed, is entitled as per discretion of procuring authority.

29. The following self certified / self attested documents should be submitted along-with the Tender. All the papers submitted with the tender are to be self certified / self attested.

i) Up to date Tax clearance certificate (TCC)/PAN number.

ii) The Earnest Money Deposit (EMD) to an amount of 50,000/- (Fifty thousand) only shall be furnished in one of the following forms.

(a) Account Payee Demand Draft.

(b) Fixed Deposit Receipt.

(c) Bankers Cheque.

The EMD shall be drawn on any Schedule Commercial Bank in India in favour of Director of Health Services, Govt.of Tripura. The Earnest Money shall be valid for a period of 45 (Forty Five) days beyond the validity period of tender. The Earnest Money will be released after validity period of contract in case of successful Tenderer and that of unsuccessful Tenderers will be released after finalization of Tender.

iii) Up to date G.M.P. Certificate issued by the concerned State Drug Controller.

(iv) Up to date ISI / ISO / BIS certificate only for Bleaching Powder and Pheneol.

(vi) Manufacturing license with approved list of products from the concern of State Drug Controller.

(vii) Copies of Valid Drug Licence & renewal certificate thereof in respect of authorized distributor.

(viii) An undertaking of the Tenderer stating that they will execute the full supply of the ordered quantity and they will abide by the terms & conditions of N.I.T., if their quoted rate is approved.

30. All the drugs should have a life period up to the maximum limit mentioned in the schedule-P of the Drugs & Cosmetic Rules, 1945.

31. Price quoted should be for F.O.R. Door delivery to (Central Medical Stores, Shyamalibazer, / G.B.P. / IGM / Cancer Hospital, Agartala) and other places in Tripura.

32. No insurance charge is admissible and successful Tenderers will be responsible for any breakage, damage and loss in transit on way to destination.

33. Any default or breach of contract and non-execution of supply order shall lead to forfeiture of earnest money/security deposit of the successful Tenderers beside to such action as may be considered appropriate by the Director of Health services including black listing / delisting the Tenderers for the future.

34. The Director of Health Services, Government of Tripura, Agartala reserves the right to accept or reject any Tender without assigning any reason thereof and Tender may be accepted or rejected in part or in whole.

35. In case of legal dispute the jurisdiction will be the Gauhati High Court, Agartala Bench.

36. The Director of Health Services, Government of Tripura, Agartala reserves the right

to unilaterally terminate the contract or cancel the acceptance of the rate and firm at any time without notice before expiry of the period for which rates are now invited.

37. 5% security deposit against value of ordered quantity of items and fresh deposit at Call are relaxed for Public Sector Undertaking subject to production of documents with the Tender.
