Sir,

I am directed to invite your kind attention on the aforementioned subject and to state that this institute is conducting a post-basic diploma course in Psychiatric and Mental Health Nursing namely Diploma in Psychiatric Nursing (DPN) since 2001. Three seats are reserved for the in-service B. Sc. Nursing/GNM nurses for each state of North-Eastern Region. As per the suggestion by Executive Council Meeting of LGBRIMH under chairpersonship of Union Secretary of Health and Family Welfare held on 27.09.13, the Institute should treat unutilized seats as "open seats" and filled up the same through an open selection process to avoid wastage of seats for DPN course. As per the order of Indian Nursing council, the session of the course will be started from October each year.

In view of the above decision, I would like to request you to kindly nominate three candidates for the said course for the session 2017-18 by 31st May 2017, failing which, such seats will be treated as "open seats" and the same will be filled up by the Institute through open selection process.
