NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Government of Tripura in consultation with the Tripura Public Service Commission is pleased to make the following rules, namely:—

- 1. Short Title and commencement-
 - (1) These rules may be called Tripura Dental Services Rules, 1995.
 - (2) They shall come into force on the date of their Publication in the official gazette.
- 2. Definitions—In these rules, unless the context otherwise requires—
 - (a) "Commission" means Tripura Public Service Commission.
 - (b) "Government" means the State Government of Tripura.
 - (c) "Governor" means the Governor of Tripura.
 - (d) "Duty post" means any post, whether permanent or temporary, of the designation specified in the first Schedule.
 - (e) "Grade" means a grade of the Service.
 - (f) "Service" means the Tripura Dental Service.
 - (g) "Member of the Service" means the officer appointed or deemed to have been appointed under the provisions of the rules.
 - (h) "Schedule" means schedule appended to the rules.

- (i) "Scheduled Castes" and "Scheduled Tribes" shall respectively have the same meaning as in clauses (24) and (25) of the Article 366 of the Constitution of India.
- (j) "Selection Committee" means the committee constituted under rule 12.
- (k) "Dental qualifications" means the recognised qualifications specified in any of the Schedules to Dentist Act, 1948.
- 3. Constitution of the Tripura Dental Service, classification, grades and scale of pay—
- (1) There shall be constituted a service to be know as 'Tripura Dental Service'. The service shall have the following grades, namely ;:—
 - (a) Grade I (Selection grade)
 - (b) Grade— II (Specialist Grade)
 - (c) Grade-III (Senior Grade)
 - (d) Grade—IV (Junior Grade)
- (2) The posts in the service shall be State Civil Service posts and their classification shall be as provided in the general order of classification of State Civil Service posts as issued by the Government from time to time.
- (3) The grades, Scale of pay, non-practising allowance of the posts in the Service and certain other papers connected therewith shall be as specified in the Second Schedule.
 - 4. Authorised strength of the service.
- (1) The authorised permanent strength in different grades of the Service on the date of commencement of these rules shall be as specified in the First Schedule, Provided that the Governor may, from time to time, create temporary posts which shall be deemed to be temporary cadre posts of the service.
- (2) After commencement of these rules, the authorised permanent strength of the service may be increased or reduced by the Government.
- (3) The Government may include in the service any posts other than those included in the First Schedule or exclude from the service a post included in the said schedule.
 - 5. Method of recruitment :-

The method of recruitment, qualification & other matters relating thereto for promotion shall be as specified in the Third Schedule.

- 6. Initial constitution of the service—
- (1) All the existing officers holding the posts of Dentist Specialist, Dentist & Dental Surgeon at the commencement of these rules shall be absorbed at the initial constitution of the service in the corresponding grades subject to their suitability being assessed by the Selection Committee constituted under rule 12 on the basis of their seniority subject to rejection of unfit.

(2) Officers who are not absorbed at the time of initial constitution of the service will continue to hold the same posts to which they were appointed prior to commencement of these rules and such officers shall continue to hold such posts till they are absorbed in the service on the basis of their suitability being assessed by the Selection Committee constituted under Rule 12 on the basis of seniority subject to rejection of unfit.

Provided absorption in the service for the purpose of initial constitution of the service shall remain open till such time all the officers holding different posts in the Department on the date of commencement of these rules are absorbed in the service.

- 7. Appointment to the service after initial constitution -
- (1) Any vacancy in any of the grades referred to in the First Schedule after the initial constitution of the service shall be filled up in the manner as hereinafter provided under these rules.
- (2) Recruitment in Junior Grade of the Service shall be made by direct recruitment on the basis of selection by the Commission subject to the age limit and educational qualifications etc. as specified in the Fourth Schedule.
- (3) The Departmental promotions shall be confined to the members of the service only.
- (4) The Departmental promotions to the higher grade shall be made on the basis of selections from amongst the members of the service in the immediate lower grade on the recommendation of the Selection Committee constituted under rule 12 of these Rules.
- (5) The minimum educational and other qualifications, experience and age limit for appointment to the duty posts included in the service by direct recruitment shall be as specified in the Fourth Schedule.
- (6) (i) Notwithstanding anything contained in these rules, the Governor may, in consultation with the Commission, appoint an officer in a vacancy in a post included in the service on deputation basis or on short term contract basis.

Provided that such person shall possess the qualifications, experience etc. as specified in the Fourth Schedule.

(ii) The officer so selected shall be appointed for a period not exceeding three years which may, in exceptional cases and in consultation with the Commission, be extended upto five years.

8. Seniority-

(1) The relative seniority of the members in a grade at the initial constitution of the service under rule 6, shall be as obtaining on the date of commencement of these rules. Provided that if the seniority of any such member has not been determined on or before the said date, the same shall be determined by the Governor in accordance with the general principles or seniority as applicable to the Government servants of other departments under this Government.

- (2) All the permanent officers included in the service in a grade shall rank senior to all officers substantively appointed to the grade subsequently and all temporary officers included in the initial constitution of the service in a grade shall rank senior to all temporary officers appointed to that grade subsequently.
 - (3) In Junior Grade merit shall be the basis of seniority.
- (4) In Grade-III (Senior Grade and Grade-II (Specialist Grade) interse-seniority between promotees and direct recruits shall be determined by rotation on the basis of quota and the rotation shall start from a promotee.
- (5) Among the promotees on same selection in the higher grades the seniority shall be determined on the basis of their merit as appearing in the 'Select' list prepared by the Selection Committee.
- (6) In the cases not covered by the above provisions, senjority shall be determined by the Governor in consultation with the Commission.

9. Probation-

(1) All appointees in the service shall be on probation for a period of two years from the date of appointment provided for service rendered in a temporary or in an officiating capacity in equivalent post under the State Government, shall be taken into account.

Provided that the Government may reduce or extend the period of probation in consultation with the Commission. (ii) Any decision for extension of the period of provation of an officer shall be taken within two months before the expiry of the probation period and communicated in writing to the concerned officer together with the reasons for so doing within the same period.

- (2) On satisfactory completion of the period of pro ation, the members of the service shall be confirmed in their respective grades.
- (3) If, during the period of probation referred to in sub-rule (1) the Governor is of opinion that an officer is not fit for confirmation, he may discharge such officer or pass order as he deems fit.
- (4) During the period of probation, officers may be required by the Government to undergo such courses of training and instructions and to pass such examinations and tests as it may deem fit as the condition to satisfactory completion of the probation.

Provided that an officer may be required by the Government to undergo such training and instructions as the Government may deem fit even after completion of the period of probation.

10. Appointment to the service-

All appointment to the service shall be made by the Governor.

- 11. Liability for service—
- (i) Subject to the other provisions of these rules officers appointed to the service shall be liable to serve anywhere in Tripura.

(ii) Such officer working in Grade-IV (Junior Grade) shall have to serve in the sub-plan area for a period not less than 3 years in his career.

12. Constitution of Selection Committee-

Recruitment by promotion in Grade-I, Grade-II & Grade-III under Rule-5 and initial absorption of the officers in the service under Rule-6, shall be made on the recommendation of Selection Committee consisting of:

- 1. CHAIRMAN: Chairman or Member of the Commission.
- 2. MEMBERS:
- (a) Chief Secretary or one available Senior Commissioner/Secretary to the Government to be nominated by the Chief Secretary.
- (b) Commissioner/Secretary of the Department to which the cadre belongs.
- (c) Commissioner/Secretary of the Tribal Welfare Department.
- (d) Commissioner/Secretary of the Scheduled Castes Welfare Department.

13. Regulation of pay-

The pay and increments of officers of the various grades shall be regulated in accordance with the Fundamental rules and other relevant rules in force from time to time relating to pay.

14. Private practice-

Persons appointed to the service shall not ordinarily be allowed private practice in any manner. They shall, however, be entitled to a non-practising allowance at the rates specified in the Second Schedule.

Provided that they may, on their exercising option to do so,, be all allowed to do private practice subject to the following terms and conditions:—

- (i) Persons allowed to do private practice shall not be entitled to non-practising allowance.
- (ii) No person shall be allowed to do private practice during his duty hours and when he is required to attend patient in the hospital.
- (iii) No person shall be allowed to keep attachment to any Nursing Home, Clinic or any institution run privately.
- "ATTACHMENT" shall mean to be on the pay roll of or to take any fees or remuneration for attending patients admitted by the nursing home, clinic or institutions on their own.
- (iv) Fees from the private patients may be charged at a fixed and resonable rate after having it approved by the Government. No fee shall be charged from those patients who are admitted in the hospitals or attended out patient Department of any Govt. medical institution.

- (v) Persons doing private practice shall be required to maintain detailed diary of private patients treated and fees charged. They shall also be required to display in their private chamber prominently the rate of fee and hours of private practice for information of the patients in general
- (vi) Persons who have opted for doing private practice may withdraw the same at any time.
 - 15. Leave, pension and other conditions of service—
- (i) Except as provided in these rules, leave, pension and other conditions of strvice of pensions appointed to the service shall be regulated under relevant rules in force in the State.
- (ii) The other conditions of service of the members of the service in respect of matters not expressly provided for in these rules, shall, subject to any special orders issued by the Government in respect of the service be the same as applicable to officers of other services of the State Government.
 - 16. Disqualifications--

No person,

- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service.

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that these are other grounds for so doing, exempt any person from the operation of this rule.

17. Disciplinary and other matters-

The members of the service shall be under the disciplinary control of the Government and subject to such control proceedings may be drawn up against them in accordance with the provisions of the Central Civil Service (Classification, Control and Appeal) Rules, 1965 as adopted by the State Government.

18. Cadre controlling authority—

The service shall be under Administrative control of the Health & Family Welfare Department under the Government.

19. Transitional Arrangements—

On and after the commencement of these rules and until persons are appointed to hold the duty post in accordance with the provisions of these rules such posts may continue to be held by the officers who are holding such posts at the commencement of these rules as if these rules have not come into force.

20. Consultation with the Commission:

All recruitment and appointment by promotion to the service under Rule-5 and initial constitution of the service under Rule-6 of these rules shall be made in consultation with the Commission.

21. Power to relax-

Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Commission, relax any of the provisions of these rules in respect of any class or category of persons.

22. Saving -

Nothing in these rules shall effect reservations, relaxation of age limit and other concession required to be provided for the Scheduled Castes, the Scheduled Tribes and the other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

23. Repeal and saving-

All provisions of the previous rules and orders, if any, made in this behalf are hereby repealed.

Provided that such repeal shall not effect anything done or any action taken under the provisions of the rules and orders so repealed.

24. Interpretation-

If any question relating to the interpretation of these rules arises, it shall be decided by the Government.

- NOTE: (i) Pay of all persons who are absorbed in Tripura Dental Service at its initial constitution shall be fixed under provisions of F.R.
 - (ii) A Dental Surgeon directly appointed in the Junior Grade of Tripura Dental Service shall draw pay in the scale of Rs. 2100-5000/- until he completes 4 (four) years of service in the grade. Thereafter, he would be eligible to draw pay in the higher scale of Rs. 3000:-5000/-

- (iii) In case of absorption in Junior Grade of Tripura Dental Service the Dental Surgeon will draw pay in the scale of Rs. 2100-5000/-until he completes 4 years of service. - v) Officers in Junior Grade and Senior Grade would be eligile for getting additional increments (a) 1 for acquiring a post-graduate Diploma and (b) 2 for acquiring a post-graduate Degree in the Specialist Dentistry subjects.

ANNEXURE-III

Note No. 24

The draft of the Tripura Dental Service Rules, 1994, is proposed by the Department, has been suitably modified It calls for the following Comments:

- 1. Method of recruitment and qualification have been specified in the Third Schedule. Rule 5 again deals with method of recruitment which seems to be in contrast with those in Third Schedule.
- 2. In Rule 6(3), there is a reference to Tripura Dental Service Rules, 1990- Perhaps, there exist no such rule and the instant rule was conceived in 1990.
 - 3. Rule 7(3) is not required, as rule 5 covers the issue.
- 4. The second proviso to Rule 7 (6) is not required, as it is the general principle followed everywhere.
- 5. It is better to specifically mention the principle of determining intrase-seniority and inter-s-seniority instead of referring to the instructions of 1960: Accordingly, the provisions have been modified.
- 6. The proviso to Rule 8 (6) is not required as seniority with reference to confirmation is now a bad law.
- 7. 'Attachment' with Nursing Home etc. in Rule 14 is required to be defined. Thave attempted a defination which may be examined by the department whether it will serve their purpose.
- 8. Reservation in promotion cannot now be introduced in any new service after Supreme Court judgement in Mandal Commission case. Therefore, Rule 18 has been modified to restrict the reservation only in direct recruitment.
- 9. The Repeal and Saving is not necessary if there exist no rule to regulate the service condition of the Dental Surgeons.

The draft rule, as modified, appear to be formally in order and may be approved.
