NOTIFICATION

In exercise of power conferred by the proviso to the Article 309 of the Constitution of India, the Governor, Tripura in consultation with the Tripura Public Service Commission is pleased to make the following rules further to amend the Tripura Homoeopathic Service Rules, 2012, namely:-

**Short Title and Commencement:-**

- i. These rules may be called the "Tripura Homoeopathic Service (Third Amendment) Rules, 2025";
- ii. They shall come into force from the date of publication in the Tripura Gazette.

**2. Amendment of Second Schedule regarding scale of pay :-**

In the principal Rules , the existing Second Schedule (A, GRADES AND SCALES OF PAY) the corresponding Pay scale / Pay level shall be as follows:- :-

**(Rule3, 14 and 15)**

**3. Amendment of Third Schedule regarding method of recruitment:**

(i) In the Tripura Homoeopathic Service Rules, 2012 (hereinafter referred to as Principal Rules) , the Third Schedule sub rule (iii) of rule 7 regarding the Method of Recruitment for the post of Grade-IA, Grade-IB, Grade-II and Grade- III shall be substituted by "100% promotion on the basis of merit cum seniority"( provision of failing which by direct recruitment under principal rule is deleted).

( ii ) **The selection to Medical Officer (Homoeo) in Gr-IV under Tripura Homoeopathy Service shall be through competitive examinations:-** (i) Written Examination (85% marks) and (ii) Interview (15% marks ) to be conducted by the TPSC as per principles of the New Recruitment Policy vide Notification No.F.20(1)-GA(P&T)/18 dated 5<sup>th</sup> June, 2019 read with the Notification of even number dated 29<sup>th</sup> October, 2020.

(iii) The syllabus and selection process pattern shall be as follows:-

**SELECTION PROCEDURE AND SYLLABUS FOR DIRECT RECRUITMENT TO THE POST OF MEDICAL OFFICER (HOMOEOPATHIC), GRADE-IV UNDER HEALTH & FAMILY WELFARE DEPARTMENT, GOVT. OF TRIPURA.**

**Part-‘A’.**

1. Written Examination: MCQ base
2. Total Marks: 85 (Eighty Five)
3. No. of question: 85
4. Duration of Exam:- One and half hour

6. There will be 04(four) alternative for the answer to every question (candidates have to choose the correct option).
7. If a candidate gives more than one answer then then this will be treated as wrong answer and no mark will be provided for the same.
8. There will be negative marking for each wrong answer attempted 1/4th marks will be deducted for each wrong answer attempted from total marks obtained by the candidate.
9. There will be no negative marking for un-attempted question.
10. Qualifying marks in Written Exam (MCQ) base):-

**Part B: Interview**

Total Marks:15(Fifteen)

On the basis of result of Written Examination , subject to securing minimum qualifying marks candidates will be called for interview as per the following ratio:-

Number of vacancies	Number of candidates to be called for personality Test (category wise)
01(one)	05 (five) candidates (1:5)
02(Two)	08(eight) candidates (1:4)
03(three) and above	3(three) times the number of post to be selected(1:3)

**Note:-** Candidate(s) scoring marks equal to that of the last candidate so selected for the interview will also be called for interview.

In the Interview following parameter are to be judge:

- i. Knowledge in concerned field.
- ii. Analytical power.
- iii. Professional attitude.
- iv. Communication Skill.
- v. Emotional attitude ethics.
- vi. Knowledge of Bengali or Kokborok
- vii. Knowledge of desirable qualification & its related communication (if any) will be judge in the interview.

**Selection Procedure:**

- a. Final selection is to be made in order of merit on the basis of marks obtained by the candidates in aggregate adding the marks obtained in the Written Examination and in the interview. If a candidate remains absent from the Interview/ Personality Test, his/her candidature will not be considered for final selection.
- b. In the list of recommendation, merit position of candidates securing equal marks will be finalized as per their date of birth. Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the final B.H.M.S Part-III Examination.
- c. The same procedure is to be followed for preparing waiting list (if any).
- d. Assessment & evaluation of answer scripts approved by the Commission in any stage is final.

**6. Amendment of Fourth Schedule :-**

Age limit and educational qualification for direct recruitment (prescribed under Principal Rules at Fourth Schedule), the Grade-I-A(Additional Director(Homoeo), Grade-I-B (Joint Director(Homoeo), Grade-II (Deputy Director(Homoeo), Grade-II(Specialist), Grade- III(Asstt. Director/DMO) are deleted and Fourth Schedule is **substituted by following entries:**
