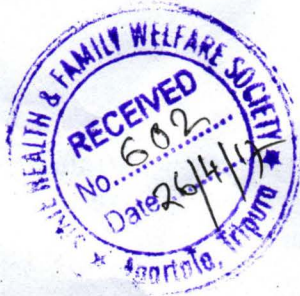


NOTIFICATION


The Board shall discharge the following functions :

1. To create public awareness against the practice of Pre-conception sex-selection and pre-natal determination of sex of the fetus leading to female foeticide in the State.
2. To review the activities of Appropriate Authorities functioning in the State and recommend appropriate action against them.
3. To monitor the implementation of provisions of the Act and the rule and make suitable recommendation relating to the Board.
4. To send such consolidated report as may be prescribed in respect of the various activities undertaken in the State under the Act to the Board and the Central Government, and
5. Any other functions as may be prescribed under the Act.
