The under mentioned personnel are hereby appointed to the post of **Nursing Officer** (erstwhile Staff Nurse) under the Health & Family Welfare Department, Government of Tripura for a period of 1 (one) year from the date of their joining the post temporarily on fixed pay basis @ ₹ 26,025/- (Rupees twenty six thousand and twenty five) only per month [i.e. 75% of the minimum slab of entry level pay in the Pay Level-10 of Tripura State Civil Services (Revised Pay) (First Amendment) Rules, 2018] **plus additional remuneration** allowed by the Government from time to time.

The appointment is purely on temporary basis and liable to be terminated at any time without assigning any reason thereof with 1 (one) month's notice from either side. It carries the liability to serve anywhere in Tripura.

The appointment is also subject to fulfillment of the conditions as laid down in the *Offer of Appointment* and other relevant rules and orders prevailing in the State from time to time.

They will report for duty to the controlling authority as mentioned in *Column No. 5* within the period from **on or before 20th March, 2024** positively, failing which their appointment shall be treated as cancelled.
