

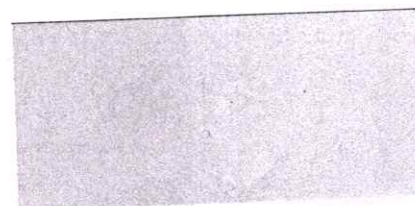



12. The Director of Health Services, Govt. of Tripura, reserves the right to accept or reject any quotation or also may cancel the SNIQ without assigning any reason.




