MEMORANDUM

Subject:- Clarification regarding countersignature of Block Development Officer (BDO / Sub-ZDO) on certificate of birth and death.

It is for information of all concerned Addl. District Registrar of Births & Deaths (BDO/Sub-ZDO) that under provision of section 12/17 of the Registration of Birth & Death Act. 1969 and the corresponding Rules framed thereunder stipulates the Registrar to issue an extract (certificate) of the prescribed particulars from the register of births & deaths to the informant as soon as the registration has been completed.

In respect of countersignature of other officer on the certificate issued by the concerned registrar of births & deaths , it is clarified that there is no provision in this aspect in RBD Act. 1969 and no such specific directions in this respect have been issued by Office of the Registrar General of India .


