

### **Corrigendum-3**

A Pre Bid meeting was held under the Chairmanship of Director, Health Services in the Office Chamber of Director, Health Services at 3 p.m on 29-02-2016 and the following important clarifications/amendments have been made:

- ❖ Technical Qualifying criteria for insurance company to work in RSBY had been uploaded in health.tripura.gov.in, and all the bidders need to meet the Qualification Criteria.
- ❖ Actuary certificate should be issued by an Actuarian.
- ❖ RSBY Tripura presently renders benefits to IPD patients and few daycare services as listed.
- ❖ Insurance Company should organize state level to block level workshops and the cost should be borne by Insurance Company.
- ❖ **Point 8 of Annexure G has been amended and bidders should quote Premium per enrolled Beneficiary Family Unit , as per the new format given below.**

Cover	Premium (in Rs.)
<b>Rs. 30,000 covers per Beneficiary Family Unit to meet hospitalization expenses on a family floater basis.</b>	<b>[insert sum] (Rupees [insert sum in words] only)</b>
<b>Top-up of INR 30,000 cover per Senior Citizen to meet hospitalization expenses.</b>	<b>[insert sum] (Rupees [insert sum in words] only)</b>

The Bidders are required to quote the premium up to two decimal points.

- I. The bidder with the lowest premium rate for RSBY Inpatient care (LPI), RSBY Senior citizen (LSI) (i.e sum of premium rate for Inpatient care, Senior citizen care ) will be awarded the contract provided the bidder also have the lowest premium rate for RSBY Senior citizen (LSI) .
- II. If LPI and LSI are different bidders, then the LPI bidder will be awarded the bid provided LPI is ready to match rate of LSI.
- III. If LPI is not ready to match LSI rate then the LSI bidder will be awarded the contract provided LSI bidder is ready to match LPI rate.
- IV. If LPI and LSI are not ready to match the bid price then LP2 bidder will be awarded the contract if they are ready to match LPI, LSI, and so on.

- V. If LP2 is not ready to match LPI, LSI then LS2 bidder will be awarded the contract if they are ready to match LPI, LSI and so on.
- VI. Wherein, no bidder agrees to match the lowest bids of LPI, LSI, then in such circumstances, the SNA shall have the authority to call for re-submission of only financial bids from all bidders again.
