Subject: Continue support in community mobilization efforts of National Deworming Day (NDD) February 2020 round.

With reference to the subject cited above, State Health and Family Welfare department, Government of Tripura would like to thanks Directorate of Panchayat for continue support in community mobilization efforts during NDD August 2019 in Tripura.

2. NDD is a fixed single day approach initiated by the Government of India in February 2015 to ensure maximum coverage with optimal utilization of resources and by leveraging existing programs and infrastructure.

3. As you are aware Deworming is significant for children as it improves their health (prevents anaemia, malnourishment, impaired mental and physical development) and leads to better education (improves attendance and retention of children in school and *anganwadis*) and livelihood opportunities (better adult outcomes and economic development) for them.

4. As the state moves towards implementation of tenth round of National Deworming Day on February 10, 2020 followed by mop-up day on February 17, 2020 in all *anganwadis* and schools (both government and private) across the state.

5. Community mobilization and awareness generation is critical component for the successful implementation of NDD program. Functionaries of panchayats officials at district, block and village can play a crucial role in sensitizing community people on importance of deworming among all children aged 1-19 years through their regular meetings held from December 2019 to February 16, 2020. Additionally, we would like to involve elected panchayats functionaries for spreading awareness in the community about the NDD among the following –

- Parents who have children in the school going age group (both enrolled and out-of-school) and motivate them to send their children to schools (in case of enrolled children) and *anganwadis* (in case of out-of-school children 1- 19 years) on NDD (February 10) and mop-up day (February 17)
- Parents of children above 1 and below the age of 6 for sending their children to *anganwadi* centres on NDD (February 10) and mop-up day (February 17).
- Participation in district, block level meetings and trainings of NDD planned from December 2019 to February 2020

6. In this regard, you are kindly requested to release a directive to concerned district and block and officials to ensure panchayats officials are actively participated in the upcoming National Deworming Day February 2020 and share a copy of the directive with State Nodal Officer, National Deworming Day program at the Department of Health (Email: nddtripura@gmail.com, 9862670872).

Our concerned officials (enclosed contact details of district officials list Annexure 1) can coordinate and reach out panchayat's functionaries for participation in district and block level trainings of NDD planned from third to fourth week of January 2020.

7. Community Handbill and poster on National Deworming Day is enclosed (**Annexure 2**) herewith for facilitation of the same.

8. Further, we will be happy to receive an action taken report on the community mobilization and awareness activities on NDD under panchayats as per template enclosed (Annexure 3) by February 28, 2020 via email at nddtripura@gmail.com
