Subject: Regarding recall of left-over/unused stock of albendazole tablets during National
Deworming Programme Sept-Oct 2020

Sir/Madam,

This is with reference to implementation of National Deworming Programme Sept-Oct 2020
conducted in Tripura from September 28 to October 5, 2020 with collaborative efforts of Department of
Health, Department of Social Welfare and Social Education, Education Department and technical assistance
from Evidence Action.

As per the directives issued by the state, the front level workers i.e. ASHAs and AWWs ^{স্বাস্থ্য} have to
handover the left-over/unused albendazole tablets to the designated ANM/MPWs along with the coverage
reporting forms.

Kindly ensure the left-over/unused drug stocks (albendazole tablets) are recalled up to district level
as per the below timeline at different levels:

- Blocks to compile status of albendazole tablets in un-used strip as well as loose tablets only (in case
of tablets still remain packed in the strip) and share with the respective districts as per given timelines.
- Districts to compile status for each block along with albendazole tablets available at district warehouse
and submit the drug recall status (district and block level) to State Nodal Officer, Health in the enclosed
format to nddtripura@gmail.com copy to shfwes_tripura@yahoo.co.in by October 18, 2020.

In this regard, you are hereby directed to ensure the recall of left-over/unused stocks as per the
guidelines mentioned above.
