- 1 The interested Firm(s)/ Organization(s) shall pay a physical inspection(s) and quote District wise rate mentioning area separately.
- 2 The applicant Agency should be a Registered Organization (Labour license from State Govt. or Govt. of India) & must have the Trade License issued by the Competent Authority of the Government of Tripura. Service Tax Registration, Professional Tax Clearance Certificate, EPF Registration, ESI Registration, Income Tax Return-last three years to be submitted along with Technical bid.
- 3 Organization should be having experience to provide services to the Govt. Sector Institutions.
