
Health & Family Welfare Department, Government of Tripura invites applications in the prescribed format from in-service (regular) nursing personnel for issuing "No Objection Certificate" in the Post Basic B.Sc. Nursing / M.Sc. Nursing / M.Phil. or Ph.D. Nursing course during the academic session 2025-26. In case of M.Sc. Nursing Course, the applicant will have to apply separately for NOC for entrance examination before appearing in the said examination both in the State & outside the State prior to applying for NOC for M.Sc. Nursing course. Applications should reach to the office of the undersigned through proper channel within the stipulated period of 02(two) months i.e. from 1st April 2025 to 31st May, 2025. Prescribed application format is available in the website www.health.tripura.gov.in.

N.B.:- The period for submission of applications has been reduced from 4 (four) months to 2 (two) months for the academic session 2025-26 for purpose of convenience.

MEMORANDUM

MODIFIED GUIDELINES FOR SPONSORING / ISSUING NO-OBJECTION CERTIFICATE / SANCTIONING STUDY LEAVE IN RESPECT OF NURSING PERSONNEL (IN-SERVICE) FOR HIGHER STUDIES

The following guidelines have been laid down for sponsoring/issuing noobjection certificate/sanctioning study leave in respect of nursing personnel (inservice) of Health & Family Welfare Department, Govt. of Tripura for higher studies in different Colleges of Nursing in the state and out-side the state:

1) Eligibility for getting No-objection Certificate:-

- A) Candidate must be in regular pay scale.
- B) Length of service
- i) 5(five) years: The candidates who have completed 5(five) years of continuous service and had service history of continuous 2 (two) years in the PHCs of remote/very difficult areas like Raishyabari, Manikpur, Hatimatha (Dalapati), 23-Kilometre PHC (Purna Mohan Tripura Smriti) of Dhalai District; Khedacherra, Bhandarima, Sabul for North District and Ghoragapppa of Gomati District subject to change of the memorandum of categories of very difficult/ remote PHCs time to time.
- ii) 6(six) years: The candidates who have completed 6 (six) years of continuous service and had service history of continuous 2(two)years in the PHCs of difficult areas like Ganganagar, Lalcherra, Nepaltila of Dhalai District; Tirthamukh in Gomati District; Baisabpur, Kwaifung, Ramraibari, Durpabari of South District and Krishnatila in Unokoti District subject to change of the memorandum of categories of difficult PHCs time to time.
- iii) 7 (seven) years: The candidates who have completed 7 (seven) years of continuous service except in the health set-ups mentioned in point (i) and (ii)
- (C) 20% of total sponsored seats will be reserved for Nursing Staffs working in PHCs located in very difficult and difficult areas. If eligible candidates are not found, then the seat will be for open category.
- 2) Upper age limit for sponsoring / issuing No-objection /sanctioning study leave is 50 (fifty) years of age as on 31st July of the respective academic year.
- 3) A Bond is to be executed through Notary between the candidate & employer stating that the candidate will serve for minimum 5 year after completion of higher study.
- 4) Once NOC issued, the next NOC/ Study leave will be given for next course after completion of 5 (five) years/ of the bond period of 5 (five) years.

- No objection for Entrance Examination will be issued from 1st April to 31st July of every academic year after submission of application through proper channel along with examination documents. No application will be entertained after 31st July of the respective year even though postal delay. But application for sponsoring/ sanctioning Study Leave will be considered after the Screening Committee meeting as decided by H & FW Dept. after 31st July of every academic year.
- 6) After issuing of NOC if any candidate apply the unwillingness to join the course within 15 days of the issue of the NOC, then from the waiting list candidate as per seniority will be issued the NOC.
- 7) After issuing NOC/ Sponsored to the eligible nursing personnel for attending the course if the candidate fails to get admission after selection, then he/she will be barred for 5 (five) years for future course and a penalty of Rs.5.00 lacs to be refunded except reasonable ground as may be decided by the Appointing Authority or NOC/ sponsor issuing authority
- a) For Post-Basic B. Sc. Nursing course:

 1% of the total man- in- position (nursing personnel) will be issued
 Sponsorship / Study leave per academic year for Post-Basic B.Sc. Nursing
 course.

b) For M. Sc .Nursing course

Nursing Staff having B. Sc. Nursing / Post Basic B.Sc. Nursing applied for M.Sc. Nursing are screened by the following criteria:


- I. from Hospital Nursing Service 20% of the total applicant,
- II. from Nursing Teaching Service 10% of the total applicant
- III. from Public Health Nursing Service 5% of the total applicant as per seniority among the applicants and 100 point roster.

c) For M. Phil / Ph.D Nursing:

Nursing Staff applied for M.Phil / Ph.D in Nursing, 10% will get NOC/ Sponsorship of the total applicant by maintaining seniority & 100% roster.

- 9) Study leave may be given once in a life time for 2 years for pursuing Master Degree / Degree / Post Masters.
- 10) For M.Phil & Ph.D no study leave will be given & if allowed then the candidate may pursue the course & in that case study period will be treated as EOL without pay.
- 11) Nursing personnel after completion of higher study will join in the same place of posting with same scale & others with proper release order from the concerned institute and will not claim for better facilities /financial benefits or as per department requirement.

- Nursing personnel if interested to study short course (INC affiliated) for minimum 6 (six) months may be allowed by deducting the said study leave period from her total study leave (i.e. 24 months) subject to permission from Appointing authority.
- 13) Appointing & sponsoring authority has full authority to give decision in case of any controversy arises.

This is in cancellation of previous Guidelines order no.1(1 -NC)-DHS/2014, dated 2015, 19th February.
