**EMPLOYMENT NOTIFICATION**

Online applications were invited for engagement to the post of **Nursing Officer** under the Health & Family Welfare Department, Government of Tripura on purely contract basis for a period of 11 (eleven) months. But Online recruitment portal of Health & Family Welfare Department experienced an unexpected downtime due to some technical issues at the Tripura State Data Centre (TSDC) under Directorate of Information & Technology. Now, the portal for submission of online applications for engagement in **100 (one hundred) posts of Nursing Officer on purely contract basis for a period of 11 (eleven) months** will again available in department's website [health.tripura.gov.in](http://health.tripura.gov.in) or [healthrecruitment.tripura.gov.in](http://healthrecruitment.tripura.gov.in) from **04/07/2025 (11:00 AM onwards) to 18/07/2025 (upto 5:00 PM)**.

Remuneration for contractual engagement is ₹ **34,700/-** per head per month. Candidates who are permanently residing in the State of Tripura within the age limit of minimum 18 years and maximum 40 years as on the date of issue of this Notification are eligible for apply. Upper age limit is relaxable by 5 years for ST/SC/PwD candidates.

No application will be entertained after the closing date and time i.e. 18/07/2025 (5:00 PM). No TA & DA is admissible for appearing interview/viva voce. The number of vacancies may increase or decrease at any stage of selection.

**Vacancies :-**

100 [SC-17, ST-31, UR-52]. Out of these 100 vacancies 2 posts [ST-1 & UR-1] reserved for Ex-servicemen; and 35 posts [SC-6, ST-11 & UR-18] are reserved for women; and 4 posts are reserved for PwDs.

**Educational Qualification :-**

(a) Diploma in General Nursing & Midwifery (GNM) OR B.Sc. Nursing OR Post Basic B.Sc. Nursing.

(b) Having registration under Tripura Nursing Council as Registered Nurse & Registered Midwife (RNRN).

*Desirable* : Knowledge in Bengali or Kokborok.

**Selection procedure :-**

Selection of candidate will be made on the criteria 50 percent from API and 50 percent from interview/viva voce. **Top API scored candidates, in the ratio of 1:3 (i.e. three candidates for one vacancy) will call for interview/viva voce.**

**Other information :-**

- The candidates, who are having PRTC, Certificate of Registration of Tripura Nursing Council (RNRN), Employment Exchange Card and requisite qualification as mentioned above, are eligible to apply for engagement.
- The engagement is purely contract basis for a period of 11 (eleven) months and will not confer any right for permanent employment or extension of contract period.
- The engagement is liable to be terminated at any time without assigning any reason thereof with 1 (one) month's notice from either side. The department, however, reserves the right to terminate the contractual engagement forthwith or before the expiration of the stipulated period of notice.
- The engagement carries the liability to serve at any part of the State of Tripura.
- The relevant rules and orders in force from time to time will govern the other condition of engagement.

**Admissibility of leave :-**

Contractual Nursing Officers will admissible for 12 (twelve) days Casual Leave and 10 (ten) days Commuted Leave (on medical ground) during the tenure of engagement for eleventh months. Any leave exceeding these periods will be treated as leave without pay.
