Online applications are invited for recruitment to post of **Laboratory Technician, Pharmacist (Ayurved), Pharmacist (Homoeopath)**, under the Health & Family Welfare Department, Government of Tripura on purely temporary and fixed pay basis @ Rs.20,475/- being 75% of the minimum slab of entry level pay in the Pay Level-9 of Tripura State Civil Services (Revised Pay) (First Amendment) Rules, 2018 plus additional remuneration increased by the Government from time to time. Candidates who are permanently residing in the State of Tripura shall exclusively eligible for applying the post within the age limit of minimum 18 years and maximum 40 years. Upper age limit is relaxable by 5 years for ST/SC/PwDs(PH)/Ex- Service man.
