- 1. The Quotation shall have to submitted in sealed cover addressed to the Project Director, Tripure State AIDS Control Society, Health & Family V/elfare Department Govt. of Tripura Akhaura Road Agartala, Tripura (West) on or before 4-00 p.m. of 16th September, 2019
- 2. On to left side of the envelop last date of submission should be mentioned. The quotation are likely to be opened on next working day at 3-00 p.m. if possible. The **Pre-Bid meeting** will be held on **11th September**, **2019 at 3-00** p.m. at TSACS office. Quotationers or their representatives may remain present at the time of Pre-Bid meeting and opening of quotations. No separate invitation will be given to the bidders.
