- Valid documents from authorized Institution as CPSEs/SPSUs/Cooperatives/ Pharmacist under State Govt. must be submitted along with tender.
- 2. Tenders will be received by Speed Post/ Registered Post/ Courier Services only in sealed covers addressed to the Head of Office, Office of the State Homoeopath, 3<sup>rd</sup> floor of Health Directorate building, Gorkhabasti, Pundit Nehru Complex, Tripura(West), Agartala, Pin- 799006 up to 16.00 hours on 06<sup>th</sup> October ,2016. The undersigned will not be responsible for any postal delay. Tenderers' are requested to provide detailed address along-with Pin Code, Phone, Fax Numbers and e-mail id for easier communication.
- 3. On the top left side corner of the sealed tender shall bear tender number and date with date of opening and name and address of the Tenderers. Tenderers or their representative may remain present at the time of opening of the tenders.
- 4. The list of medicines and other items is given in annexure-A.

- 1. The interested bidders shall submit the bids in 2 parts, namely "Technical Bid" and "Financial Bid". The two bids should be put in two separate sealed envelopes, indicating on the cover as to which one is the technical bid and which one is the financial bid. The two envelopes shall, thereafter, be placed inside a large sealed cover and the same may be submitted. The "Technical Bid" shall contain all details regarding the list of Medicines offered by the bidder, compliance of terms and conditions, submission of documents, etc. In other words, everything except the rate offered. The "Financial Bid" shall contain only the rate offered by the bidder. While processing the bids, the technical bids will be opened first and eligible bidders meeting requirement will be short listed. Thereafter, financial bids of only shortlisted bidders will be opened for consideration.
- List of medicines along with detailed specification and standard and name of the manufacturer quoted by the bidder is to be enclosed in the technical bid.
   Each item of medicine shall be treated separately and shall be considered accordingly.
- The supply of medicines must be executed within 90(Ninety) days from the date of manufacture and shall have a shelf life as per the provisions of schedule P of the Drugs and Cosmetics Rules, 1945.
- 4. Medicines must be supplied directly by the manufacturer and should obtain sales tax clearance before delivery. An authorized representative of the firm should remain present during delivery of the ordered quantity. Authorized representative shall have to furnish appropriate credential from the firm they represent.
- 5. The manufacturers must have GMP certificate issued by the concerned State Drugs Controller in respect the items quoted by the tenderer.

- 6. The supply order of medicines must be completed within stipulated period 90(Ninety) days. A penalty @ 1% on the total value shall be charges for every week or part thereof for delay beyond the stipulated date of supply for a maximum period of 04(four) weeks after which the order shall be deemed to be cancelled. However, relaxation will be entertained only in special circumstances (Natural calamities, War or any other situation beyond human control). Order must be executed by supplying the items batch wise and maximum quantity of each batch is to be supplied.
- 7. During execution of supply orders, the manufacturers/ tenderers will have to submit the in-house Test Report and a test report from NABL.
- 8. Samples of each batch of medicine supplied shall be tested by the State Drugs Testing Laboratory (STDL) .The State Drug Control Administration will collect sample of medicines/drugs, etc. from the Store at random within 03(three) days from the date of receipt of drugs by the store.
- 9. If any batch of drugs supplied is found to be not of standard quality after testing at the time of receipt or during shelf life period of the drug, the entire stock should be taken back and replaced by fresh stock at the own cost of supplier/ tenderer to the respective institutions.
- 10. The tender will remain valid up to 01(One) year from the date of acceptance. The Director of Health Services, Govt. of Tripura has reserves the right to extend the rate for a suitable period to the approved supplier.
- 11. Failure to supply standard quality of medicine/ drugs by the tenderers will render him disqualified along with the manufacturer of the drugs for further supply/tender.
- 12. If ordered quantity is less and ordered value is less than Rs.50,000.00 (Rupees Fifty thousand) only for one item of medicine, the medicine will be received with the in-house test report of manufacturer itself. The medicine will also be tested at STDL, Agartala for which testing facilities is available with it. If testing facility is not available at STDL, then medicines having less ordered quantity and less than Rs.50,000.00 (Rupees Fifty thousand) only will be received with the in-house test report of manufacturer itself.

- 13. Income tax/other tax shall be deducted from the bill as per guidelines of the Government as may be applicable from time to time.
- 14. Any enhancement of rate within the validity period of contract will not be considered except for imposition of any levy or increase in existing levy by the Government.
- 15. Payment to successful tenderers shall be made on bill basis only after completion of supply of items ordered for. No advance payment shall be made under any circumstances.
- 16. Extension of rate for supply may be considered for a further suitable period to the approved supplier on the basis of satisfactory performances and execution of supply orders in time and in terms of quality.
- 17. The rate should be typed and quoted both in figure and word clearly in Indian currency. The unit cost of medicines, rate of CST and VAT should be mentioned separately and clearly in the financial bid. No overwriting shall be entertained in any circumstances.
- 18. Approximate requirement is incorporated in the list of medicine, etc. which are likely to be increased or decreased as per actual requirement and supply order may be placed in parts or full.

The medicines should conform to the standards mentioned against each item and as laid down under the Drugs & Cosmetics Act & Rules and should also comply the provisions prescribed in the Drugs Price control order, 1995. The medicines which do not fall within the definition of homoeopathic medicines require separate license issued under the Drugs and Cosmetic Rules,1945 for supply.
- 20. In case of supply of each and every item the label of packing, strips/blister etc. should bear the inscription <u>"Head of Office, O/O the State Homoeopath supply, not for sale"</u> in indelible ink. Relaxation, if needed, is entitled as per direction of procuring authority.

- 31. In case of legal dispute, the jurisdiction will be the High Court of Tripura.
- 32. The Director of Health Services, Government of Tripura reserves the right to unilaterally terminate the contract or cancel the accepted rate and firm at any time without notice before expiry of the period for which rates are now invited.
