1. Quotation shall have to be submitted in sealed cover addressed to the Project Director, Tripura State AIDS Control Society, Health & Family Welfare Department, Govt. of Tripura,Akhaura Road, Agartala, Tripura (west) up to 4 p.m. of 18th December, 2020.

2. On the left side of the envelope last date of submission should be mentioned. The Quotations are likely to be opened on next working day at 3-00 p.m. if possible. Quotationers or their representatives may remain present at the time of opening of quotations. No separate invitation will be given to the bidders.

3. The interested bidders shall submit the bids in 2 (two) parts, namely Financial Bid and the Technical Bid.
