B) Introduction:-

An **Expression of Interest (EOI)** is hereby invited by the Director of Health Services, Government of Tripura, Agartala (on behalf of the Governor of Tripura) from licensed Pharmacist having D. Pharma or B. Pharma Degrees with valid pharmacist registration certificate of Tripura or Individual entrepreneur or NGO/SHG/Government Societies.

Individual entrepreneur or NGO/SHG/ Government co-operative Societies applying for a PMBJK should have a Pharmacist employed under him/them having D. Pharma / B. Pharma Degree having valid pharmacist registration certificate of Tripura .

E) Eligibility criteria to open "Pradhan Mantri Bhartiya Janaushadhi Kendra" (PMBJK).

Following shall be minimum technical eligibility criteria for selection of agency for PMBJK

- F) Individual entrepreneur or NGO/SHG/Government co-operative Societies applying for a PMBJK should have a licensed Pharmacist having employed under him/them having D. Pharma or B. Pharma Degrees with valid pharmacist registration certificate of Tripura for Expression of Interest (EOI) for Opening of Pradhan Mantri BhartiyaJanaushadhi Kendra" (PMBJK).
 - 1. The bidder shall be a Pharmacist having D. Pharma or B. Pharma Degrees with valid pharmacist registration certificate of Tripura or Individual entrepreneur or NGO/SHG/Government Co-operative Societies having a Pharmacist employed under him/them having D. Pharma / B. Pharma Degree having valid pharmacist registration certificate of Tripura. The bidder shall be permanent resident of the Panchayat/Village Council/Nagar concerned Gram Panchayat/Municipal Council/Municipal Corporation. The first preference will be given to the Pharmacist failing which preference will be given to unemployed NGO/SHG/Government Co-operative Societies and then to the Individual Entrepreneurs. In case where more than one pharmacist is applying for a particular Institution, in such case the senior pharmacist in respect of date of birth will be given preference. And in case of NGO / SHG/ Co-operative Societies, the firm with earlier registration and in case of Individual Entrepreneurs, the senior most person as per date of birth will be given preference. Pharmacist or Individual Entrepreneur having age up to 60 years will be allowed to participate in the **Expression of** Interest (EOI).

2. If no bidder is found for a particular Institution then bidder of other district will be considered.

3. The selected bidder will be responsible for all clearances/formalities including drugs licence from the State Drug Controller for opening the chemist shop in the allotted space of Hospital/Health institution. In case of successful bidder who is a Pharmacist, the drug licence shall be in the name of the successful bidder showing himself/herself as Pharmacist in the said Drug licence.

4. It shall be the responsibility of the bidder to obtain Drug License in the name of "Pradhan Mantri Bharatiya Janaushadhi Kendras (PMBJKs)" and other permissions to

run a Drug Store. Compliance to all statutory requirements for Storage of Drugs shall be ensured by the applicant. If the bidder does not set up computerized system/software, permission will be liable to be cancelled.

5. All operations of Pradhan Mantri Bharatiya Janaushadhi Kendras (PMBJKs) will be conducted as per the guidelines of BPPI. For more details the bidder may visit the website www.janaushadhi.gov.in

6. It shall be the responsibility of the bidder to obtain registration of GST.

7. Successful bidder will stock and sell Generic Medicines, Medical devices and Food supplements procured from BPPI. In addition they can also stock and sell other Generic medicines, Medical devices and Food supplements which are not available /supplied by BPPI. The products other than that supplied by BPPI shall be from WHO-GMP/COPP certified manufacturing unit only.

8. The bidder shall not sell the medicine procured from BPPI at a rate exceeding the printed MRP. However, any Generic Medicine procured other than BPPI shall have been sold with a discount of 20 % on Medicines and at least 30% discount on medical devices procured.

9. The successful bidder shall invariably keep at any point of time stock of at least 60% Generic Medicine of Essential drug.

10. The bidder shall inform everyday in the morning preferably at 9 AM to the head of the Institution about the present stock position of medicines in his/her counter.

11. The bidder must have the financial capability to run the Pradhan Mantri Bharatiya Janaushadhi Kendras (PMBJKs).

12. The Health & Family Welfare Department will notify the successful bidder in writing that the bid has been accepted and issue Letter of Indent (LOI) to the successful Bidder.

13. Within 7(seven) days of receipt of such intimation the successful bidder shall give its acceptance to the Director of Health Services, Govt. of Tripura.

14. The Bidder will not be required to submit any EMD for participating in the Expression of Interest (EOI).

15. The successful bidder will enter in to an agreement after furnishing the performance security of Rs 5,000.00 (Five thousand) only.

16. The contract period shall be preferably for 5(five) years, which can be increased or reduced by the Health & Family Welfare Department.

17. The successful bidder shall have to keep the PMBJKs open and in normal operation starting from 09.00 Hrs to 19.00 Hrs. with the option of Tiffin and lunch break and to ensure 24(twenty four) hours service on call basis.

18. The successful bidder shall provide within 10(ten) days of being informed, the list of men/women who are likely to be employed. The list shall contain individual personal

details like name, address, educational qualification, nationality and contact number. The information furnished shall be supported by documentary evidence.

19. All the personnel shall maintain official decorum abide by rules and regulation of the Hospital/Institution. The successful bidder shall be responsible for conduct and performance of each person.

20. Each customer shall be provided Tax Invoice having valid GST number.

21. Health & Family Welfare Department will provide space, electricity free of cost inside the Government Health Institution premises. However, furnishing of the room including installation of refrigerator and internal wiring for electricity shall have to be arranged by the bidder. All other private investments shall have to be ensured by the bidder under Bureau of Pharma Public Sector Undertaking of India (BPPI) mode within the broad guidelines of Government of India available at the website-www.janaushadhi.gov.in

22. The successful Bidder shall start operating the PMBJK unit within 3(three) months from the date of allotment of award failing to which the award will be treated as cancelled and fresh award will be given to the next bidder participated for that Institution.

23. PMBJKs would be set up in 132 uncovered Health Institutions up to PHC level (As per enclosed list at Annexure-I). Intending bidders may participate in the open bid giving specific choice/preference of Health Institutions appearing in Annexure-I.

24. The successful bidder have to deposit security money of **Rs. 5 thousand before signing** of the agreement in the shape of DD from a nationalized bank in favour of the Director of Health Services, Govt. of Tripura, Agartala.

25. As per guideline of BPPI the successful bidder under the scheme can get an incentive up to Rs. 5.00 lakh @ 15% of monthly purchase made, subject to a ceiling of Rs. 15,000/-per month. In addition, an onetime incentive of Rs. 2.00 lakh will may be provided in the form of furniture & fixtures in case of Kendras opened in North-Eastern or Himalayan areas, Island territories, inspirational districts or opened by woman, divyang , SC or ST entrepreneurs . H) Instruction to Bidders

The tender document may be downloaded from the office website www.health.tripura.gov.in however, bidder have to submit with technical bid with a DD from a nationalized bank of Rs. 1000/- as a tender fee which is non refundable drawn in favour of Director of Health services, Govt. of Tripura, Agartala.

While all efforts have been made to avoid errors in the drafting of the tender documents the bidder is advised to check the same carefully No Claim on account of any errors detected in the tender documents shall beentertained.

Each page of the bid documents must be stamped and signed by the authorized person or

persons submitting the bid in token of his/their having acquainted himself/themselves and accepted the entire bid documents including various conditions of contract. Any Bid with any of the Document not so signed is liable to be rejected at the discretion of the institute.

The Person signing the bid document on behalf of the bidder shall attach the copy of the authorization letter/power of Attorney as the proof of authorization for signing on behalf of the bidder.

All bidders are hereby explicitly informed that conditional offer or offers with deviations from the conditions of contract, the bids not meeting the minimum eligibility criteria, bids not accompanied with supportive documents, or any other requirements, stipulated in the EOI shall be summarily rejected.

I) Bid & Bid Evaluation

1. Prior to the detailed evaluation of Technical bids will be done on the basis of scoring criteria at Page no-22, Director of Health services, Govt. of Tripura, Agartala will determine the substantial responsiveness of each bid to the Bid document. Substantially responsive bid will be one which confirms to all the terms and conditions of bid document without material deviation. The determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence.

A bid determined as substantially non-responsive will be rejected and shall not subsequent to the bid opening be made responsive by correction of the non- conformity points by the bidder. However, Director of Health services, Govt. of Tripura, Agartala may waive any minor infirmity or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any bidder.

If there is discrepancy found in any document, then the decision of Director of Health services, Govt. of Tripura, Agartala shall be final in this regard and the bid will be rejected if the bidder does not agree to the decision in this regard.

2. Tendering firms are at liberty to be present or authorize a representative to be present at the opening of the Technical Bid at the time and date as specified in the Schedule. The name and address of the representative authorized to attend the opening of the tender on behalf of a tendering firm should be indicated in the tender. The representative so deputed should also bring with him a letter of authority from the firm for having been authorized to be present at the time of opening of tender. Only one representative per firm shall be permitted to attend the opening of the tender. The name and address of permanent representative of the firm, if any, should also be indicated in tender.

J) Right To Accept Or Reject Any Bid:-


i. Tender will be accepted and Contract will be finalized with only those who in the opinion of Director of Health services, Govt. of Tripura, Agartala shall have capability to run Janaushadhi Kendra.

ii. Director of Health services, Govt. of Tripura, Agartala reserves its right to accept or reject any bid without assigning any reason whatsoever. Director of Health services, Govt. of Tripura, Agartala reserve the right (I) to reject any or all tenders (ii) the right to accept any portion of the tender offered without assigning any reason and he can also reduce or extend the period of contract without assigning any reason.

iii. In case the selected bidder fails to execute the bid agreement within stipulated period, the Institute shall be free to enter into contract agreement with next selected bidder agreeing to provide services as a selected bidder.

I) Terms and Conditions for opening of PMBJK (Shop)

The brand (Generic) medicines are sold at significantly higher prices then there unbranded generic equivalents, though are identical in the therapeutic value. Given the

wide spread poverty across the country, making available reasonably priced quality generic medicine in the market would benefit everyone. With this objective, the pharma advisory forum in april 2008 decide to launch the Janaushadhi campaign – starting with the sale of generic medicine through dedicated sales outlet called "Pradhan Mantri **Janausha**dhi Kendra" in various places of the country. To provide medicines to all health centres at Tripura under Health & Family Welfare Department at low cost Director of Health Services, Govt. of Tripura, Agartala is inviting EOI to open a **Janausha**dhi Kendra.

General Terms and Conditions and Instructions to the bidder

1. The Tenders Technical Bid) should contain all the relevant papers in support of eligibility criteria, , Licenses, etc. should be super scribed "Tender for opening of PMBJK(Pradhan Mantri **Janausha**dhi Kendra) under Health & Family Welfare Department, Govt. of Tripura, Agartala. Sealed tenders to be addressed to the Director of Health Services, Govt. of Tripura, PN complex, Gurkhabsti, Agartala, Tripura, Pin no-799001.Bids sent through courier and bids submitted after closing date of bid submission shall not be entertained. The bid shall be valid for 120 days from the date of opening of bid.

2. The Checklist of technical information, format of experience and financial capacity of bidder along with declaration in the prescribed proforma should be submitted along with the Technical Bid with Annexure-D, E, F.

3. The Technical Bid should be accompanied by a Tender Fee (non-refundable) only in the form of Demand Draft only from any scheduled Bank drawn in favour of The Director of Health Services, Govt. of Tripura, payable at Agartala.

4. The successful bidder has to deposit 5 thousand as Performance Security Deposit in shape of Demand Draft / Bank Guarantee from any Nationalized Scheduled Bank in favour of "Director of Health Services, Govt. of Tripura, Agartala." Security deposit shall remain valid for the period of sixty (180) days beyond the date of completion of all contractual and statutory obligations of the agency.

15.The agency should have

a. Proof of securing a pharmacist with computer knowledge (name of the pharmacist, registration with the state council to be furnished).

b. The agency have to arrange at their own cost furniture in the shop like racks to store medicines counter for issue of bills and medicines to patients, office table , computer tale and chair / stools etc. for working staff.

c. There should be two display boards (one horizontal and second vertical) over the shop following the language, logo design and other colour combination as provided by BPPI.

e) The successful bidder has to meet minimum requirement for BPPI web based software and will have to install computer with higher / latest specification.

f) There should be a Refrigerator in the shop for storage of medicines at the required temperature as per drug and cosmetic Act.

16.The successful bidder will recruit the staff for running the PMBJK as per the requirement at their own cost.

17.All billing should be done using software provided by BPPI. No medicine can be sold by PMBJK without using the software provided by BPPI.

18.Medicines sourced and supplied only by BPPI, will be allowed to be sold through PMBJK. The list of medicines will be dynamic and may be altered after approval from the competent authority.

19.It shall be the responsibility of the operating entity to obtain drug license and other permissions to run a drug shop. Compliance at all statutory requirement for storage of drug shall be ensured by the agency.

20.The operating agency should run the shop from 9AM to 6PM or round the clock, it required.

21.This tender is only for establishment of opening of PMBJK (SHOP) at Health Centres under Health & Family Welfare Department, Govt. of Tripura, Agartala.

22.The agency will use the premises solely for the purpose for which it has been allotted and for no other purposes and shall not port with the premises, sub-let the shop to anyone directly or indirectly.

23. The agency will keep the premises in hygienic and functional condition.

24.The agency will obtain retail sale Drug License/ sale tax/ VAT numbers from the competent authority to run the shop having a pharmacist and other qualified staff.

25. The agency will provide the generic medicines directly from the C&F agent/ super stockist appointed by BPPI.

26.The agency will not use the store/ shop for sale of other than Generic medicines or any unauthorized or illegal or extraneous/ obnoxious / banned drugs which are spurious, soiled, damaged, post- dated or expired or adopt any unfair means to boost the sale.

27.The agency will issue computer generated receipts, for each sale which will include name of medicine(s), pack and quantity, batch no., date of manufacturing and expiry, sale price, discount allowed, taxes, if any, as per Govt. norms.

28.The agency will pay service taxes and other central and local taxes from time to time hereby imposed by Government.

29.It will be permitted to access to BPPI, and central Govt. through its authorized person(s)/ party at all reasonable times for purpose of inspecting the shop and also the place where the medicines have been stocked. Such party or its agents are authorized to seize any unauthorized items being sold in the shop without any valid permission or sanction of law.

30.The agency will abide by the direction issued by the Director of Health services,Govt. of Tripura, Agartala and Govt. of Central and State from time to time for keeping the shop as well as premises property maintained & clean for running of shop, besides observing the relevant laws such as drug laws & Act, labour laws, shop and establishment registration etc, as applicable.

31. Agency will be responsible for any type of losses and damages caused on the shop.

32. The agency will not sell medicines having shell life of 3 months or less.

33.Further, operational issues arising from time to time will be decided with mutual consent of all the concerned parties.

34. The performance of the Agency selected to run the Generic medicine shop will be assessed at the end of year. A committee formulated under Health & Family Welfare Department, Govt. of Tripura, Agartala will assess in this regard and report to the Director of Health Services, Govt. of Tripura, Agartala. According to the report, the Director may grant further extension to the agency.

35.Successful bidder will stock and sell Generic Medicines, Medical devices and Food supplements procured from BPPI. In addition they can also stock and sell other Generic medicines, Medical devices and Food supplements which are not available /supplied by BPPI. The products other than that supplied by BPPI shall be from WHO-GMP/COPP certified manufacturing unit only. If found selling other items other than that is mentioned above then the agreement will be treated as cancelled and the agency have to vacate the campus on receipt of notice from the Director of Health Services, Govt. of Tripura, Agartala.

36. The agency shall furnish a copy of price list of medicines kept for sale, to the Director of Health Services, Govt. of Tripura, Agartala authorities and shall also make available copy of the same at all the time and at the time of inspection/ verification. If it is found that product exhibited for sale is sold by the agency at higher rate than shown in the price list furnished by the agency and no agreemented discount has been given, the same shall be considered as breach of the terms and conditions of this agreement. A soft copy of the entire price list in a Microsoft Excel format should be supplied to Director of Health services, Govt. of Tripura, Agartala on fortnightly basis during the period of contract.

37. Director of Health Services, Govt. of Tripura, Agartala will not provide any technical assistance in setting up of generic medicine shop.

38.The agency shall at its own cost appoint their own adequate staff to run the said shop as stated above to the satisfaction of the Director of Health Services, Govt. of Tripura, Agartala. Such staff appointed by the agency shall not be treated as the staff of Directorate of Health Services, Govt. of Tripura, employees and shall have not any claim or lien on Director of Health Services, Govt. of Tripura, properties for any dues. Further the agency shall not engage or employ any person suffering from any disease, contagious, infectious, or otherwise dangerous to human life and health.

Agency has to submit name, bio data and copy of Aadhaar Card at DIRECTOR OF HEALTH SERVICES, GOVT. OF TRIPURA, AGARTALA of person employed to run the JAS. No person other than the name shown in the submitted list should be found in the shop. Prior information must be given to the DIRECTOR OF HEALTH SERVICES, GOVT. OF TRIPURA, AGARTALA if there is any change of employee in the shop

39.The agency shall at their own cost maintain and keep the said shop in good hygienic condition and will keep it neat and clean and shall make its own arrangement for removal of refuse and garbage as directed by authorities.

40.The agency shall not construct and encroach upon the open space or any adjoining open space besides that allotted to the agency. Any such encroachment will be deemed to be breach of the terms and conditions of the agreement.

41.It is hereby agreed by and between parties that at all time the possession of the area / building of shop shall be with the Director of Health Services, Govt. of Tripura,

42.It is hereby agreed that on expiry of the period of permission/period of agreement or an earlier on its revocation, Thereof, the agency shall at their own cost remove all articles and things belonging to them from the said premises shop area and handover vacant and peaceful possession. In default, the Director of Health Services, Govt. of Tripura, Agartala shall be entailed to enter the premises and occupy the same and/or to put their own lock. 46.The Agency shall not do anything or supposed to be done anything in the premises, which may cause nuisance or annoyance or inconvenience to the Director of Health Services, Govt. of Tripura, Agartala officials or patients
