Functions:

- 1. to grant, suspend or cancel the registration;
- 2. to enforce the standards for genetic counseling centre, genetic clinic and genetic laboratory
- 3. to investigate complains of breach of provisions of the Act and the rules
- 4. to take the complaints to the court
- 5. to take appropriate legal action against the use of any sex selection technique by any person at any place, suo motu or brought to its notice and also to initiate independent investigations in such matter.
- 6. to create public awareness against the practice of sex selection or pre-natal determination of sex
- 7. to supervise the implementation of the provisions of the Act and Rules;
- 8. to recommend to the board and state boards modifications required in the rules in accordance with changes in technology or social conditions;
- to take action on the recommendations of the Advisory Committee made after investigation of complaint or suspension or cancellation of registration.

Powers.

- a) Summoning of any person who is in possession of any information relating to violation of the provisions of this Act or the rules made there under
- b) Production of any document or material object relating to clause(S)
- c) Issuing search warrant for any place suspected to be indulging in sex selection techniques or prenatal sex determination and
- d) Any other matter which may be prescribed.
