NOTIFICATION

In exercise of powers conferred by Rule-17(2) of the Act, the Governor, Tripura is pleased to appoint the District Magistrates & Collector of West, Sephajala, Khowai, Gomati, South, North, Unakoti, Dhalai District as Appropriate Authority under the afore mentioned Act.

2. The Appropriate Authority shall have the following functions under 17(4) of the Pre-Natal; Diagnostic Techniques (Prevention& Misuse) Act, 1994 as amended in 2002;

- a. to grant, suspend or cancel registration of a Genetic Counseling Centre, Genetic Laboratory or Genetic Clinic
- b. to enforce standards prescribed for the Genetic Counseling Centre, Genetic Laboratory or Genetic Clinic
- c. to investigate complaints of breach of the provisions of this Act on the rules made there under and take immediate action and
- d. to seek and consider the advice of the Advisory Committee, constituted under Sub-section(5) on application for registration and on complaints for suspension or cancellation of registration.

3. The District Magistrate may nominate an Executive Magistrate of the District as his nominee to assist him in monitoring the implementation of the PC& PNDT Act, 1994 as deemed necessary.
