Accordingly you are hereby requested to send the mobile numbers of all the Registrar/Sub-Registrar /DEO under Private Hospital/Nursing Home (Institutional and Non-Institutional) within 24th December 2021 for further action from this end .

All the Registrar of Births & Deaths are please ensure to update the mobile numbers for Two factor authentication in future also . Otherwise the **Users of the CRS Portal will not able to login into the Portal from 3rd January 2022.**

Sir/Madam,

ORGI is in process to introduce **OTP** (One Time Password) as Two factor authentication for Login into CRS Web Portal, for which, process will be as follows:

- i). ORGI will register Chief Registrar's mobile numbers into the CRS web portal, which will be used for sending OTP(One Time Password) for Login into CRS web portal through Chief Registrar's User ID.
- ii). Subsequently, Chief Registrar will have facility to enter mobile numbers of District Registrars/Registrars/Sub-Registrars and similarly District Registrar will enter the mobile numbers of Registrars/Sub-Registrars.

2. OTP (One Time Password) as Two factor authentication for login into CRS Web Portal will be implemented from 10th December 2021 for Chief Registrars and 12th December 2021 for District Registrars and 3rd January 2022 for Registrars/Sub-Registrars.

3. The Chief Registrar's mobile number has to be shared with the ORGI before 08th December 2021.

4. The Chief Registrar will assure for updation of mobile number of District Registrars before 11th December 2021.

5. Further, the District Registrars will assure updation of mobile numbers of Registrar/Sub-Registrars before 02nd January 2022.

6. All Chief Registrars, District Registrars & Registrar/Sub-Registrars please ensure to update the mobile Numbers for Two factor authentication in future also.

7. Rest of the Users will continue to Login in CRS Portal without using second factor of authentication i.e. OTP based.
8. ORGI will impart ONLINE training to Chief Registrars on 09th December 2021, through MS Team at 11:30 AM. The link will be shared one day before the commencement of training.

Therefore, it is requested to initiate collecting the Mobile numbers, email IDs and User IDs of the concerned District Registrars/Registrars/Sub-Registrars for updation of mobile numbers before due date.
