TERMS AND CONDITION

- 1. The Quotation shall have to submitted in sealed cover addressed to the Project Director, Tripure State AIDS Control Society, Health & Family Welfare Department Govt. of Tripura Akhaura Road Agartala, Treipura (West) on or before 26th July 2018.
- 2. On to left side of the envelop last date of submission along with reference nos. etc should be mentioned. The quotation are likely to be opened on 27th July, 2018 at 3-00 p.m. if possible. Quotationers or their representatives may remain present at the time of opening of quotations. No separate invitation will be given to the bidders.
- 3. The interested bidders shall submit the bids, duly self attested, in 2 (Two) parts namely Technical bid and the Financial bid in 2 (two) separate sealed envelopes indicating on the cover as to which one is the Technical bid and which one is Financial bid. The 2 (two) envelopes shall, thereafter, be placed inside a larger seal cover and the same, duly super-scribed with the above mentioned reference no., may be submitted. The Technical bid shall contain all details regarding the items offered, terms & condition and submission of documents etc. i.e. the Technical bid shall contain everything except the rate offered. The Financial bid shall contain only the rate offered by the suppliers/ agencies / person(As in Annexure 1). While processing the Technical bid will be opened first and the eligible suppliers/ agencies/ person fulfilling all requirements will be short listed. - 5. The rate will be valid for Two years initially or till the project period, whichever is earlier. The age of the Vehicle should not be more than 4 (four) years old. If the vehicle is purchased in the current year, relaxation may be given for sl. 6 a, c and d below.
- 6. The following self attested document should be submitted along with Technical bid:

- 7. Non Submission of any document as stated above will lead to cancellation of bid.
- 8. The agency shall be responsible for timely supply of Fuel, Lubricant & Duster etc. for vehicle.
- 9. The Vehicle may run anywhere in the State of Tripura as when required by this office. Driver of the vehicles should maintain Log Book on daily basis.
- 10.All maintenance cost including salary of Drivers, Co- Drivers, Cleaner & Technicians, , etc., will be borne by the Owner. No insurance charge or any other charges is admissible.
- 11.A fixed amount of Rs. 200/- only will be provided to the driver towards fooding, lodging, etc while on tour with night halt, if any and to be billed during the concerned month.
- 12. For the Vehicle, hired on monthly basis, should be placed for duty within 10 (Ten) days from the date of issue of order along with valid commercial driving license of the driver of the hired vehicle.
- 13. The successful bidder will be liable for the incidence of any loss breakage/accident & legal matters etc. in connection with the vehicle. In case of any defect, breakdown, accident etc. If it occurs at any time, resulting the vehicle unfit for service, this shall be made up by placing another Vehicle within 2 (two) hours in order to avoid interruption of this programme, failing of which a penalty of Rs. 30/- (Thirty) only per hour will be deducted.
- 14.No claim for advance payment will be entertained. Payment will be made by e-transfer on bill basis along with relevant up-to-date logbook. All applicable Tax should be mentioned clearly/ separately along with %. All taxes will be deducted as per norms.
