

1. The tender shall be submitted in sealed cover addressed to the Director of Health Services, Government of Tripura, Gurkhabasti, Agartala before **16.00** hours of 12/00/ 2018. Tender will be received by **Registered Post/Courier Service/Speed post**. The undersigned will not be responsible for any postal delay etc.
2. On top left side of the envelop, tender number with date and due date of the tender and name & address of tenderer should be mentioned. The tenders are likely to be opened on next working day, **if possible**. Tenderer or their representative may be present at the time of opening of the tender.
3. The tenderer shall quote rate per kilometre per 100 kg. Inclusive of all charges what so ever (I.e. Fuel, maintenance of vehicle, loading, unloading, ferry, tools ,any other tax etc.) **rate should be quoted by words and figures clearly**, otherwise tender will treated as **Cancelled**.
4. Each page of tender shall be signed by the tenderer. Where the tenderer is a partnership firm each partner shall sign each page of the tender and shall furnish a power of attorney in favour of a partner who shall represent the firm in all matters what so ever.




