

The undersigned will not be responsible for any postal delay etc. Tender are likely to be opened on next working day, **if possible**.
2. On the top left side of sealed envelop, tender inquiry number name & address of tenderer should be mentioned with last date submission. The tender forms will be issued on application up to 16.00 hour on **16/09/2019** from the office of the undersigned.
3. Rate should be quoted both in figures and words per ltr./kg./Nos. Rates of shredded empty saline bottles & used X-ray Film are to quoted per kg. Rates of used Hypofixture solution are to be quoted per ltrs. And empty phenyl drum (plastic & Tin) per nos.
4. Earnest money of **Rs. 2,500/- (two thousand five hundred)** only at call deposit on any Scheduled National Bank in favour of Director of Health Services, Govt. of Tripura Agartala and up to date Tax Clearance Certificate should be furnished along with the tender.
