The Tender will remain valid up to **31-3-2020**.

TERMS AND CONDITIONS.

1. The tender shall be submitted in scaled cover addressed to the Director of Health Services, Government of Tripura, Gurkhabasti, Agartala before **16.00** hours of 23/4/ 2018. Tender will be received by **Registered Post/Courier Service/Speed post**. The undersigned will not be responsible for any postal delay etc.
2. On top left side of the envelop, inquiry number with date and due date of received of tender and name & address of tenderer should be mentioned. The tenders are likely to be opened on next working day, if **possible**. Tenderer or their representative may remain present at the time of opening of the tender.
3. The tenderer shall quote Rate per kilometre per 100 kg.inclusive of all charge including (l,e.Fuel, maintenance of vehicle, loading,unloading,ferry,tools octopi,any other tax etc.) Rate should be quoted by words and figures clearly, otherwise tender will treated as Cancelled.
4. Each page of tender shall be signed by the tenderer. Where the Tender is a partnership firm each partner shall sign each of the tender and shall furnish a power of attorney in favour of a partner who shall represent the firm in all matters what so ever.
5. The intending tenders must deposit a sum of **Rs.10,000/- (Rupees Ten thousand)** only as earnest money in favour of Director of Health Services, Government of Tripura, on Demand Draft from any scheduled Bank. The earnest money of unsuccessful tender will be refundable after selection of the tender. The undersigned reserves the right to forfeit the earnest money if the successful tenders fail to comply with work order or causes breach of contract in any other way.

 - ii. GST Registration Certificate
 - iii. Valid Tread Licence.

Accepted tenderer shall be responsible for breakage, damage and loss of any articles in transit and shall not make the payment of value of loss/damaged goods as may be determined by the undersigned. 10. No enhancement of the rate shall be entertained during the validity period of tender.
