It is for information of all concerned Registration units of Birth & Death (Health Institution/Non-Institution that, as per RBD Act. 1969 registration of every events of Birth, Death and Still Birth with issue of extract / certificate(s) of registration will be done as follows :-

Sl. No.	Clarification	Under Section of the RBD Act. 1969	Fee charged
1.	Registration within the prescribed period (within 21 days)	Under Section 8 & 9	No fee would be charged
2.	Issue of Extract of Registration (A birth & Death Certificate is to be issued)	Under Section 12	No fee would be charged
3.	Issue of Extract of Registration in other occasion	Under section 17	Searching fee Rs.2/- per year and Rs. 5/- for extra per copy.
4.	Birth or Death event , information on which is given to the Registrar after expiry of 21 days but within 30 days of its occurrence shall be registered on payment of late fee .	[Rule9 (1)]	Rupee 2/- only Rupees 5/ only for certificate
5.	Birth or Death event , information on which is given to the Registrar after 30 days but within one year of its occurrence shall be registered only with in the written permission of the prescribed authority and on the production of an affidavit made before a notary public and payment of a late fee	[Rule9 (2)]	Late fee Rupee 5/- only Rupees 5/ only for certificate
6.	Birth or Death event which has not been registered within one year of its occurrence shall be registered only on an order made by a magistrate of the first class after verifying the correctness of the event and payment of late fee	[Rule9 (3)]	Rupee 10/- only Rupees 5/ only for certificate
7.	Non availability Certificate in form No-10 in case of delay registration procedure .	Under section 11	Searching fee Rs.2/- per year and Rs. 5/- for the NAC in form 10.
8.	Name of Child can also be entered after one year but within 15 years of registration on payment of late fee	Section 14 of Rule 10	Rupees 5/- only for late fee Rupees 5/ only for certificate.
