Subject: Escalation matrix for raising grievances/ queries related to Central Licenses/ Applications.

FSSAI has an **online platform** namely Food Safety Compliance System (FoSCoS) for the issuance of pan-India FSSAI License and Registration. For Central Licensing procedures as laid down under FSS Act 2006 and Rules and Regulations made thereunder, FSSAI has appointed Central Licensing Authorities (CLA). The details of these CLAs are available at <https://www.fssai.gov.in/cms/designated-officer.php>

2. In case any Food Business Operator(FBO) is aggrieved by the decision taken by the CLA, below is the prescribed **escalation matrix** for the FBO to represent its case:
