**NOTIFICATION**

Family Planning Indemnity Scheme (FPIS) was introduced by Govt. of India on 1<sup>st</sup> April 2013 which indemnifies all the clients of sterilization as also doctors conducting sterilization operation in both public and accredited private/NGO sector health facilities for unlikely events of complication/failures/death attributable to the sterilization operation.

2. In order to improve the quality of Family Planning services, it has been decided to **double the quantum of compensation** fixed under FPIS as per the direction of Hon'ble Supreme Court of India. The additional amount shall be borne out of **State Health Budget** as per details given below:-

3. The revised coverage is effective from **1<sup>st</sup> January 2017** onwards.

4. State & District Quality Assurance Committee shall ensure strictly implementation of the revised coverage under FPIS.
