- 3) To provide security personal in the Hospital mainly at Night. In this matter decision will be taken by the committee members and accordingly letter will be issued to Superintend of Police.

- 5) Doom to be hired temporarily against RKS fund.
- 6) It is decided that next meeting will be held on 4th January 2017.

At the Outset Dr. Subrata Baidya, Executive Cum Member secretary, RKS AGMC & GBPH Agartala apprised about the action taken on the decision taken in the previous meeting held on 28th December 2015, agenda wise. After detailed discussion with all the participants following decisions were taken:

- 1) It has been decided that one refrigerator & one water purifier will be installed in the nurses' duty room of the new cabin complex.
 - 2) It is also decided that 10 / 15 no's of sofa cum bed will be purchased for all the cabins. This will facilitate the stay of patient parties as attendants inside of the cabin.
 - 3) After detailed discussion RKS body decided to fixing of window nets for all the wards & action will be taken by the help of PWD.
 - 4) It was decided that a vacuum cleaner and washing machine will be purchased for all the work station like OTs, ICUs, Post operative ward and HDUs.
 - 5) It is also decided to purchase two dryers for NTH I to dry up the floor & walls after cleaning.
 - 6) It is also decided that four Drivers will be recruit for driving three new ambulances which had been supplied to AGMC & GBPH Hospital in last one or two years, the salary of the driver will be Rs.400/- (Rupees four hundred) per call on voucher basis up to eight hours.
 - 7) It is also decided that to recruit one control Panel Operator for AGMC & GBPH Hospital
 - 8) It is decided that one Control Panel Operator will be recruited AGMC & GBPH especially in the Present scenario of shifting Dept of orthopaedics to NTH I.
- It is also decided that there will be recruitment of one Plumber on daily Basis if when required as per market rate.
- 10) After discussion of the RKS meeting it has been decided to purchase of following items
 - a) Steel Almeria- 20 (twenty) no's
