You are hereby requested to submit the rate for conducting Food Safety Audits in the State of Tripura on the following items:


1. 50(fifty) nos. audit of manufacturing units all over the state.

6. The conducting Food Safety Audits in the State of Tripura should be completed **within 03(three) months** from the date of issue of the work order.


